MINUTES
REGULAR GOVERNING BOARD MEETING
February 10th, 2014

1. The meeting was called to order at 6:00 PM
2. Jo Burke made the motion to adopt the Agenda. The motion was seconded by Jackie Harshman and the Agenda was adopted with a unanimous vote.
3. Information Items
 - a. Judy McBride, Rock School Committee Chairman, prepared a Power Point presentation of the history of Beaver Creek School. Beaver Creek Preservation and Historical Society (BCPHS) proposed to preserve the Old Rock Schoolhouse at Beaver Creek School. BCPHS objective is to gather, preserve and share the important history in Beaver Creek with the community. Judy stated that the goal was to preserve the Rock Schoolhouse, but in order for that to happen there are repairs that need to be completed. Those repairs include but are not limited to:
 - i. Clean out loose mortar and stones at all exterior cracks.
 - ii. Restore the south entry door.
 - iii. Repair drainage; route water away from the building to keep water from pooling around it.
 - iv. Patch plaster and paint to match.

During the efforts of the preservation BCPHS will submit the nomination form (ROPE) to the State Historic Preservation Office. BCPHS hopes to seek

National Historic Registry status, and eventually create a historic schoolhouse museum. Karen DuFresne would like the BCPHS proposal to be an action item on the next Board Meeting.

The combined purchases need to be ratified. The total amount spent on the counter and flooring was 5390.52.
