### I. CALL MEETING TO ORDER

The Special Meeting of the Plymouth Board of Education on Monday, March 27, 2023 was called to order at 6:30 pm by Vice Chair Kulesa.

### II. DISCUSSION AND POSSIBLE ACTION ON BOARD HEARING PURSUANT TO CONNECTICUT GENERAL STATUTES SECTION 10-151\*

Attorney Stephen Sedor stated he is the procedural advisor pursuant to Connecticut General Statutes Section 10-151.

Attorney Sedor asked all parties to identify themselves:

Attorney Sedor stated at the last meeting Administration had finished direct examination of the Superintendent and now will be cross-examination by counsel for the Teacher. Attorney Mills stated at the last meeting there were some things that had not been admitted to the record and requested that Superintendent's Exhibit 6 be admitted into record with one question needed of the Superintendent,

Attorney Balding stated remaining questions are for private session.

Attorney Sedor recommended the Board go into Executive Session.

Upon completion of the re-cross-examination, Attorney Sedor excused Mr. Falcone as a witness at 8:50 p.m. called for a 5-minute recess.

Meeting was called back in session at 9:03 p.m.

Attorney Mills called Detective Damien Bilotto to the stand.

Detective Bilotto was sworn in as a witness by Attorney Sedor.


