IV. Action - Personnel

- 1. Recommend to accept the resignation of Jacob Schultz, 7th and 8th grade ELA teacher, effective 11-17-2017. (attachment)
- Recommend to accept the resignation of Rickey Nicks for the purpose of retirement effective 11/06/2017.
- Recommend the appointment of Albert Coleman as Activities director for the remainder

 stipend.

- Recommend the re-assignment of Natasha Clay from Library Media Specialist to Instructional Facilitator, effective 7-3-17 – contract to change from 220 days to 240 days.
- Recommend additional duty assignment for Alisha Beard as Food Services Coordinator and Liaison to Aramark Food Services. Supplemental stipend TBD.
- 7. Recommend additional duty assignment for Jessica Jefferson as Cheerleader Sponsor, effective 8-7-2017 for \$3,500.
- 8. Sick Leave payout at retirement: Current policy permits the accumulation and carry forward of 90 days of sick leave. In discussion with the chair of the local PPC, there was no discussion pertaining to the discontinuance of the practice of sick leave payout that was not included in a recent adoption of the ASBA recommended policies. We have two individuals that believe they were delaying the sick leave payout until January of 2018. It is recommended that up to 90 days of sick leave payout be permitted for individuals retiring at the end of school year 2016-2017. This amount would be at the substitute rate for the respective position.

Despite the contracting for services, the district is still required to continue oversight of the food services program. WHEREAS, Arkansas Virtual Academy is an open-enrollment public charter school that draws students from the Earle School District; and

WHEREAS, the Arkansas State Board of Education granted Arkansas Virtual Academy a series of waivers, including a waiver of Ark. Code Ann. §6-10-106.
