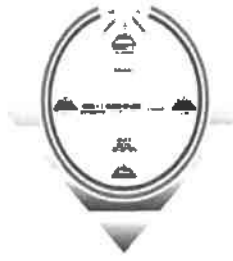

Minutes of Virtual Public Meeting Of the Governing Board of the Ganado Unified School District No. 20 November 4, 2021 at 6:00 p.m. from the District Board Room, Ganado, Arizona

- I. **CALL TO ORDER:** Mr. Marcarlo Roanhorse, Board President called the meeting to order at 6:08 p.m.
- II. **ROLL CALL:** Judy James was present in-person; Teresa Gorman was present by zoom; Marcarlo Roanhorse was present in-person and by zoom.

- A. ***Discussion and possible action regarding procedures for Superintendent's annual evaluation and performance pay.**
***Possible executive session per ARS 38-431.03(A)(1) Personnel and ARS 8-431.03(A)(3) Advise from legal counsel.**
Nathan Schott with Hufford, Horstman, Mongini, Parnell, Tucker, LLC provided a synopsis of what transpired in executive session: He stated that they discussed possible procedures for conducting the Superintendent's annual evaluation and for performance pay for the first half of this school. After some discussion and questions it would be his recommendations that the board use the following procedures to conduct both the annual evaluation and performance pay. He recommended that since all the board members have both the annual evaluation instrument which is set forth in policy CBI-E that each board member individually complete that evaluation and the board members also have to have the performance pay rubric which is part of the Superintendent's contract. He recommends that each board member individually completes that performance pay rubric when those documents have been completed, he would recommend that each board member go ahead and provide those completed evaluations and performance pay rubric to the board secretary. Once the board secretary has all the board member's evaluation and performance pay rubric and recommend that the secretary forward those documents to the office of Hufford, Horstman, Mongini, Parnell, Tucker, PC. At which time, Mr. Schott will take a look at all the documents and prepare a cumulative evaluation with all of the board member's evaluation scores and comments. He will also prepare a second document with all of the board member's votes on the performance pay. He will prepare all of those documents ahead of the December 2, 2021 board meeting at which time the board will have another executive session to discuss both annual evaluation instrument and the performance pay. Due to the timing of all of this, there are some breaks coming up at the end of this month, he would recommend and request that all board members provide their completed evaluations and rubric to Ruth Kanuho, no later than November 19th, two weeks from tomorrow. This should give us

enough time to prepare, collate and into BoardDocs with enough time for the board to review in advance of the December 2, 2021 board meeting. A. Summary of Current Events.

1. **Superintendent:** Dr. Dobias stated that the district just started the pool testing. She stated that everything is in and the testing should start Monday or Tuesday, because Group A and Group B have to be done in the morning, in the afternoon and shipped out. Dr. Dobias stated that the damaged bathrooms in the field house is being repaired. These are damages from the flooding that occurred a year ago.
2. **Governing Board:** Mr. Roanhorse stated that the board attended an ASBA Apache County Meeting and elected a County Director to represent Apache County at the Arizona School Board Association Director's Meetings. He stated that Ms. Judy James was re-elected in holding a position as one of ASBA Board of Directors. Congratulations, Ms. James. Ms. James wanted to congratulate board members for their years of service on the board which was awarded at the Apache County Meeting last week.

B. Celebrations and Recognitions. Lynette Lookingback, Athletic Director presented the following: She stated that GHS Volleyball team will be traveling to play in the first round of the playoffs, to play the number 1 seed, Chandler Prep. If they advance, they will play on Saturday, November 6, 2021. She recognized the North Volleyball, All region as Mya Dalgai, North Offensive Player of the Year; 1st Region team: Lauren Bums; Laverio Makenna Manuelito. 2nd Region Team: Kelanna Bitsuie; Kiara Curtis and Kayla Watchman. The Cross country team took first place at the 2A North Regional Championships in Hopi last week. She announced Mica Slivers and Anna Marie Yazzie as the individual champions. This past Wednesday, they traveled to Holbrook and both team men and women qualified for state. The boys team took 1st place and the girls team took 2nd. Mica Slivers took championship. They will be running next Saturday at Cave Creek Golf Course. Next month would be the 2A Football all region selections. Thank you for all your support.
