## Nemo Vista Elementary SMART Goals

1. **Long Term Goal:** On the 2022 SQSS: Reading at Grade Level Score will increase by 5% compared to the 2021 SQSS: Reading at Grade for 2019 SQSS was a score of 58.33%. No test was conducted in 2020 due to Covid. On the 2021 SQSS was a score of \_\_\_\_%. New goal is \_\_\_\_%.

**Short Term Goal:** On the STAR Assessment, 80% of the students will increase their reading level each Semester from the Spring 2021 to the Spring of 2022. From Fall 2020 to Spring 2021, 85% of the students increased their reading level. No data was collected in the Spring of 2020 due to Covid.

2. **Long Term Goal:** On the 2022 SQSS: Student Engagement Score will increase by 5% compared to the 2021 SQSS: The 2019 score is 70.92%. No test was conducted in 2020 due to Covid. The 2021 score is \_\_\_\_% New goal for 2022 is \_\_\_\_%.

**Short Term Goal:** 65% of the students will maintain 3 or less absences quarterly. Data collected in August, 2020 to April, 2021 showed that 2,255 days were missed by students in grades K-5. This data is distorted due to quarantines from Covid.

3. **Long Term Goal:** 75% of the students scoring below the 50%tile on the Map Testing in math will show growth through every testing period. In Fall 2020, to the Winter 2020, 93% % of the students scored below the 50%tile showed growth. In Spring 2021, \_\_\_\_% of students scored below the 50%tile showed growth.

**Short Term Goal:** 75% of the students designated as scoring below the 50%tile on the Map testing will show improvement on the STAR Math given quarterly. From Fall 2020 to Winter 2020, 95% of the students that scored below the 50%tile on the Map Test showed improvement of the STAR Math test.
