ATTENDANCE/ABSENCE POLICY

The Office of Child Development and Early Learning (OCDEL) require regular attendance of all children participating in Pre-Counts. Children must have an attendance percentage of 85% or better to retain Pre-K Counts funding. Failure to maintain the 85% attendance will result in loss of funding. If your child has more than 2 unexcused absences per month, a family meeting will be scheduled.

Basic excuses that are considered “legal” reasons for being absent from school:

- Illness
- Religious reason
- Death in immediate family
- Natural disaster and/or severe weather
- Reasons agreed upon by administration in advance

Late Arrival/Tardiness: It is important that your child arrive on time and be ready to learn when they come to class.
