MONDAY, JANUARY 30 & TUESDAY, JANUARY 31

An ONLINE registration portal will be active on January 30 and January 31. This live link will be available by visiting our website at www.tcjackets.net and on social media for registration. If you need access to a computer, please call Hand-In-Hand at 229-225-3908 and ask for Trish Kearce who will schedule an appointment to assist you in registering your child. All eligible students signed up for pre-k on January 30 and January 31 will be guaranteed a slot. Out-of-district students will be accepted upon approval by the Board of Education.

FOR PRE-K: Child **MUST** be 4 or 5 years old **ON** or **BEFORE** September 1, 2023

FOR KINDERGARTEN: Child **MUST** be 5 years old **ON** or **BEFORE** September 1, 2023

A link will be available during online registration to schedule your child's screening appointment.

REQUIREMENTS FOR SCHOOL ENTRY:

- ◆ Certified Copy of Birth Certificate
 - ◆ Shot Record (Form 3231) (Name on shot record **MUST** match name on birth certificate)
 - ◆ Eye, Ear, Dental (Form 3300) (You will get this at the four year old check-up. If your child is not four yet, you will not have this form.)
 - ◆ Child's Social Security card
 - ◆ Parent/Guardian ID
 - ◆ For Pre-K ONLY(if applicable) Copy of SSI card, Medicaid card, Temporary Assistance to Needy Families (TANF), Child and Parent Services (CAPS), or Supplemental Nutrition and Assistance Program (SNAP)
 - ◆ Proof of Residency
- ACCEPTED **MUST have two(2) of the following**
- ◆ Utility bill
 - ◆ Mortgage statement or lease
 - ◆ Property tax statement
 - ◆ Homeowner's insurance bill
 - ◆ Vehicle registration
- NOT ACCEPTED
- ◆ Driver's license
 - ◆ Cell phone bill
- ◆ Proof of Residency *if living with someone else*
 - ◆ Signed and notarized affidavit from the property owner PLUS property owner's *proof of residency
 - *see above for proof of residency requirements
 - ◆ Children **MUST** reside in the state of Georgia to attend a Georgia Pre-K program
