School wide

Type of Title I program where all students that are enrolled in a school are considered to be Title I, including preschool students *

*Limited definition for the purpose of determining reporting status.

For additional information see NCLB Statute Title I Part A Sec. 1114.

Targeted

Type of Title I program where only students that receive Title I services can be identified as Title I students. *

Only students that receive services will have a T1A code in Program Fact.

*Limited definition for the purpose of determining reporting status.

For additional information see NCLB Statute Title I Part A Sec. 1115.

Title I, Part A Basic Program Code

T1A

Used to identify Title I, Part A Students.

In School wide Schools all students have a TIA.

In Targeted Schools only students that receive services have the TIA.

In schools that do not receive Title I, Part A funds no student will have this program code

NEW CODE FOR SY 2015-16

T1APK

Use this code to identify preschool students that are in a program funded by the District Level Title I Pre K set-aside.

This extra set-aside can be given to Pre K Programs in school wide, targeted, or non title I schools.

NM Pre K Programs can also receive this extra funding



Title I, Part A Funded Preschool

New Code Reporting Rules

- In School wide schools that have a preschool that does not receive the extra set-aside funds, only the T1A code will be used for all students – including the Pre K.
 - In School wide schools that have both the extra Pre K and Title I Basic site allocation students will have both the T1A and T1APK codes.
 - In targeted schools the code will be used if the Pre K has the extra set-aside funds. The T1A code will also be used for any student that is also served by the school’s targeted program.
 - If the Pre K program receives only the extra Pre K funds then only these students will have the T1APK code.

Title I , Part C Migrant Education Program Who are Migrant Students?

1. They have been identified through an eligibility process by the district migrant coordinator.
2. They have been identified by the federal Migrant Data Exchange system – MSIX and have had their eligibility verified.
3. Their eligibility once verified will result in a Certificate of Eligibility (COE).

Title I , Part C Migrant Education Program Migrant Students **continued**

They may arrive in your district during the summer months. If they do you are obligated to report them.

According to federal MEP guidelines, Migrant Students with a Certificate of Eligibility (COE) are to be enrolled and reported in the Summer School Collection even if they receive no services in your district.

Title I, Part D Program Overview

- Title I, Part D is a federal fund that supports students who are who are neglected, delinquent, or at risk. New Mexico and the LEAs that **receive** Title I, Part D are obligated to report the students served by this program to the federal government in the Consolidated State Performance Report.



Staff Compensation

- **STATE + FEDERAL + T1A + T1C + T2 + MEDICAID + PUBLIC + PRIVATE = 100**
 - Compensation type = T1A or T1C
 - Compensation Category = FEDPGM
 - Compensation Percent = % paid by T1A or T1C entered as a whole number where 50% = 50.
 - Aggregate at the district level for teachers that work at multiple locations.

Staff Compensation

Example:

A reading teacher works at all four Title I elementary schools. Each location has this teacher as a 25 FTE. This teacher’s total FTE is 100.
