The school uses web-based site to post grades and communications between teachers and parents. Teachers and parents are connected through Remind, emails, and phone calls. Parents are given a PIN number for the eSchool TAC/HAC system.

School Packet is distributed at the beginning of each year with information and forms for parents to read and sign.

Student Handbook is issued to students outlining school expectations and procedures. The parent-friendly parent and family engagement plan is included in the student handbook. Parents sign to acknowledge they have received it.

Parents have access to the school website that includes school news, a school calendar, and other pertinent information. Twitter information is also found on the school district website.

Families are involved in a variety of roles through the PWHS Booster Club. Participation is encouraged and information is disseminated through Facebook for activities, events, meetings, etc.

School electronic sign is updated daily and posts events, meetings, etc.

Teachers do individual volunteer interest forms or surveys for specific classrooms, clubs, field trips, etc.

The school will distribute Informational packets each year that includes a copy of the school's parental involvement plan, survey for volunteer interests, recommended roles for parents/ teachers/students and school, suggestions of ways parents can become involved in their child's education, parental involvement activities planned for the current school year and information about the system that will be used to allow parents and teachers to communicate (Remind, notes, phone calls, email...).

Annual Report to the Public by the principal is delivered in the evening to encourage parent participation.

Parent Facilitator is available for meetings with parents individually to help lessen barriers to parental involvement.

A School Parent Compact is used to promote responsibility of grades and behaviors. A meeting will be called in April inviting parents and students to work with teachers to improve the compact for the next school year. The Compact is one way stakeholders recognize that student learning is a shared responsibility.

The partnership between home and school and regular two-way productive communication are important elements in the process of student success. Parent/Teacher conferences are held twice a year, and Progress Reports are sent out every four and a half weeks. Reports on student progress are readily accessible on the eSchool TAC/HAC system. Teachers and parents are connected through Google Classroom, Remind, emails, and phone calls as well as in person at school or school functions. FAFSA Night, course planning, career day and college fair are some of the actions used to encourage continued communication with parents to improve student academic achievement.

The school website includes school news, a school calendar, and other pertinent information such as Fine Arts Night which showcases art work, drama performances, and band performances of the students.

Parents are given opportunities to volunteer to assist in a variety of student activities and learning opportunities. Teachers encourage parents to participate in various ways aligned with their interests. School staff are encouraged to compile volunteer surveys so the listings may be utilized by parent interests.

Community resources are used in a variety of ways in the instructional program. Teachers utilize career people from the college, law school, electric cooperative, military, educational cooperative, and artist community to enhance learning.

Building tours are provided to new students and parents Ex. Open House and 6th graders moving up to 7th grade.

Registration Night in the spring allows parents to participate in choosing educational and career pathways for their child/student. High school teachers collaborate with elementary teachers for older students to work with the younger students.

Resources will be provided through the high school library as well as the principal's office and counselor's office. Parents are encouraged to check out materials, use the computer to check grades, fill out FAFSA information, and visit educational Web sites. College and career ready resources are made available through counselor as well as pamphlets that promote and support responsible parenting.

PWHS has a small student population, yet families are involved in a variety of roles through the PWHS Booster Club. Participation is encouraged and information is disseminated through Facebook for activities, events, meetings, etc. School Staff involves the club in appropriate decisions and dissemination of information.

PWHS School Resource Officer, Beck Spur and Old Fashion Baptist Churches are in the schools each day to offer assistance to strengthen school programs and learning, encouragement to support responsible parenting, and related endeavors.

A bulletin board is posted in the main school hallway highlighting newspaper events dealing with current and alumni PWHS students. Alumni are invited to speak in classrooms or various meetings to inspire current learners.

The parent and family engagement plan is comprehensive and coordinated in nature and will be assessed through review. The plan will be incorporated into the school's improvement plan.

Meetings requested by parents as well as regularly scheduled meetings will be held. Currently, meetings are scheduled for November 5, 2020 and March 8, 2021.

Teachers develop a syllabus to assist parents and students in understanding standards, curriculum, assessments, and academic goals necessary to achieve success in their course content.

Teachers distribute state-mandated assessment results and explain how to understand the outcomes. Student reading levels are assessed and reading resources, reading guidance and strategies are disseminated to parents to support their child's academic success. Teachers utilize academically and developmentally appropriate lessons for the students.

Google Classroom allows parents to actually see student work being done in class. Teachers use Remind to keep parents informed about major projects, assignments, and deadlines. Interim scores and handouts to parents keep them informed and knowledgeable about student learning, standards, and academic achievements.

Tools available for student and/or parent use include the ADE website http://www.arkansased.gov, Khan Academy, Newsela, IXL, etc. These tools provide support and assistance to promote academic learning and understanding of concepts.

Parents are encouraged to be actively involved in academic decisions affecting their child including course selection, career planning, and preparation for college and career opportunities. After developing a plan of action with their student, parents are required to sign course planning documentation. The school hosts College Meeting Days, Military and College Day, and FAFSA Night to assist in the decision making process.

A digital media parenting support course is being designed to enable parents to better assist with student achievement.

PWSD has partnered with K-12 Culinary Connection to provide nutritional meals during school hours. School and community tastings were held to highlight the new menu items being offered at the school. Culinary selections are posted on Facebook to encourage nutritious eating.

PWHS operates a Backpack Program which supplies a backpack of nutritious food items for disadvantaged students to take home who might otherwise miss meals.
