The attached Addendum is issued for the purposes of amending certain requirements of the bid and hereby made part of and incorporated in full force as part of the Contract Documents. Unless hereinafter specifically noted or specified otherwise, all work shall conform to the applicable provisions of the Contract Documents.

BID ADDENDUM NO. 2 DESCRIPTION:

Item 1: Pre-Bid Clarification (Request for Information) – Questions and Responses:

Question #1:

1. In scope of work #3. Bugeye style lights to be installed above all exterior doors in rooms designated for LED lighting conversion.
Fixture type is on #4. ELM-LED-803
 - a. Are these going inside the room and removing or repositioning the Exit sign?
 - b. Are these going on the exterior wall above door?

District Response:

- a. The District does not want any exit signs removed or repositioned.
- b. The bugeye style lights are to be ceiling mounted near the exterior door (approximately within 3 feet) utilizing a T-bar style bracket with a junction box. If a room has 2 exterior doors, the bugeye lights are to be mounted by the one with the exit sign.

Question #2:

2. I am requesting the substitution of RMJ-5T-DV-B as it is obsolete and no longer available, the replacement model is RMJS-8T-DV-B.

District Response:

Please utilize model RMJS-8T-DV-B for the Power Pack.

Question #3:

3. The PICO-RF-434 W LED is not a valid part number but seems to be a description that can describe several different items. We would like to encourage the district to please review the Lutron Pico wireless control document to select the correct part.

District Response:

Please utilize PJ2-2BRL-GWH-LO1 for the controller.

Question #4:

4. In materials to be used #3. Retro kit (1 each per room)
 - a. VEKT2x4L-840 Retro kit
 - b. 36W 2x4 LED Retrofit kit 0-10 4000K (or equivalent approved by the District)

Are these two different types of fixtures? Or is it just one fixture with the description of the fixture the District is requesting.

District Response:

It is only one fixture; item B is a description of the fixture the District is requesting.

5. What is the estimated project budget?
