M-CSD RE-1 has 2,800 students, including a diverse student population comprising 50% Native American or Hispanics, approximately 70% eligible for free or reduced lunch, 1 high school, 1 middle school, 5 elementary schools, 3 charter schools, including an alternative high school.

Cortez is located where the mountains meet with desert in the southwest corner of Colorado. The District includes the City of Cortez, the Ute Mountain Ute Reservation, Mesa Verde National Park and a large rural area close to desert and mountains.


