B. REMOTE LEARNING

Recommended Motion: that the Board move that consistent with the Interim Guidance for Remote Learning for the 2021-2022 School Year as issued by the Connecticut State Department of Education, effective with the commencement of the 2021-2022 school year, the Brookfield Board of Education (“Board”) shall discontinue offering remote learning opportunities for students associated with the COVID-19 pandemic. The District shall no longer provide students with voluntary access to remote learning at the unilateral request of students/families. The Board authorizes its Superintendent of Schools to take such actions necessary to implement this change. The Board further authorizes the Superintendent to take any emergent steps necessary relating to remote student programming associated with the COVID-19 pandemic or other emergencies as may be needed, subject to the Board's subsequent approval.
