The Jasper City Board of Education met on September 15, 2022 at 4:00 p.m. at the central office conference room. Vice-Chairperson Walker Wilson called the meeting to order at 4:06 p.m. with the first item to be approved being the agenda. A motion to approve the agenda was made by Scott Thornley and a second by Teresa Sherer. The motion carried.
