DESCRIPTION

G.R. Woolfolk Social & Political Science Building (0503) is located within the quad on A.G. Cleaver Street. Constructed in 1932, the building originally served as the Education Building. This Georgian Revival building reflects the same masonry characteristics found throughout the university campus. It was designed by architect Frederich Ernst Giesecke. The building retains sufficient integrity of location, workmanship, materials, feeling, and association to remain recognizable to its period of significance.


Elegant Mexican tile placed on the second and third floor lines distinguish the building. The high pitch of the roof exposes a single copper cupola intended to encase a clock. Special attention was placed on the main entrance way with the more subdued pilaster rising to an additional pilaster line to expose the grandeur of this structure. The Mexican tile-work is continued around the base of the roof and on all four corners are the owlfaced gargoyles. The main building components of the building are brick, masonry, detailed tile-work and copper.

During the 1987 Rehabilitation and Repair Project the entire interior was rearranged. The entire building was air conditioned and the asbestos roof shingles were removed. The ADA compliance requirements were met by the installation of a ramp located at the rear. This required the construction of a back entrance, which subsequently reduced the size of the large lecture room (108) on the first floor. This also allowed for the addition of an elevator and the restrooms were relocated to either side. The classrooms on the main floor on the outer west and east end changed very little in size. However, the most change came on the third floor were the Stack room (305) and Reading Room (302) were divided into small office spaces to accommodate the enlarging faculty and staff. At this time the Education building was put on line with the computerized control room in the power plant for heat, air and fire alarm monitoring. Throughout this project special attention was placed on the plants and trees. Special notes with instructions regarding the replanting, tree protection and underground irrigation lines were incorporated within the A/E's design plans.





STATEMENT OF SIGNIFICANCE

Built in 1932, the G.R. Woolfolk Social and Political Science Building was erected to house the university's Education Department. The building is related to the historic context, *Development of Prairie View A&M University*, 1876-1998 and is nominated under Criterion A in the areas of Education and Ethnic Heritage at a state level of significance.

Dr. Frederich Ernst Giesecke (1869-1953)

Prominent Texas architect and engineer Frederich Ernst Giesecke designed a number of significant buildings on the Prairie View campus in the early 20th century. He graduated with a Bachelor of Science degree in Mechanical Engineering from Texas A&M in 1886. Directly after graduation he became an Assistant Professor of Mechanical Engineering there and in 1888 he became the head of the department of mechanical drawing when it was separated from the department of mechanical engineering. He did graduate work at Cornell University, the University of Illinois and Massachusetts Institute of Technology. In 1907 he spent a year studying heating and ventilation at the Technical University of Berlin. He published some of the first authentic articles on the subject in *Heating and Ventilating Magazine* when he returned. Giesecke left Texas A&M in 1912 to head the Department of Architecture at the University of Texas at Austin. From 1914 to 1920 he served simultaneously as a Professor of Architecture and as the Head of the Division of the Engineering Bureau of Economic Geology and Technology. Giesecke left UT in 1923 to earn a Ph.D. at the University of Illinois. In 1927, Giesecke returned to Texas A&M as the Head of the Department of Architecture and the College Architect. In 1928 he became the Director of the Texas Engineering Experiment Station. While at A&M Giesecke experimented with rodding concrete, paving the way to ready-mixed concrete. His articles on this subject led to the acceptance of reinforced concrete structures.

Dr. Giesecke was extremely active in professional organizations within his field. He was instrumental in organizing the Texas Chapter of the American Institute of Architects (inducted 1906). He was a charter member (1891) of the Society for the Promotion of Engineering Education (now the American Society of Engineering Education) and later served as the president of the Texas Section. He was a life member of the American Society of Heating and Ventilating Engineers and served as the president of the American Society of Mechanical Engineers. In 1942 Dr. Giesecke received the F. Paul Anderson Gold Metal for Outstanding Contribution to the Science of Heating and Ventilating. In addition, Dr. Giesecke remained dedicated to education and authored a number of articles and textbooks including *Technical Drawing* (1936, with Alva Mitchell and Henry Spencer) which has become a standard text for engineering students.

Dr. Giesecke designed the laundry building (1916), the Spence Agricultural Building (1918), and the George R. Woolfolk Social & Political Science Building (1927, originally the Education Building) on the Prairie View campus. He collaborated with Prairie View's own College Architect, Louis Fry for the design of the Hospital

(1928) and worked with Prairie View Mechanical Engineer C.L. Wilson to design the Animal Industries Building (1920), L.C. Anderson Hall (1933), and Hilliard Hall (1939). Giesecke created a sense of continuity between the buildings he designed for the campus and three buildings in particular show similar detailing. L.C. Anderson Hall stands as an excellent example of traditional campus gothic design and is similar in style to G.R. Woolfolk Hall. A 3-story gabled and parapetted ornamental stone entryway distinguishes Anderson Hall. Two bays with flattened arches flank this central entrance, while upper portions of the entry are framed by tapering piers. Despite much more modest detailing, the G.R. Woolfolk Hall, with its pedimented central entrance and balance resembles Anderson Hall. Architectural embellishment linking Anderson and Woolfolk Halls includes stone owl head detailing, stone embellishment and grand entrances of the two buildings. Similar tile embellishment visible on the exteriors of Woolfolk and Hilliard Hall link those buildings as well.

George Ruble Woolfolk

George was born in Kentucky in 1915, the fourth son of Lucien and Theodosia Woolfolk. He received the Bachelor of Arts Degree at Louisville Municipal College, the Masters of Arts Degree from Ohio State University and the Doctor of Philosophy Degree from the University of Wisconsin. He joined the history faculty at Prairie View A&M in 1943. Within a few years he met and married Douglass, who became his devoted wife and lifelong partner. They had one son, George R. Woolfolk Jr., who resides in Dallas.

Dr. Woolfolk's performance as a research scholar, teacher, and chairman of Division of Social Science earned him listing in the Directory of American Scholars, Who's Who in the Southwest, Who's Who in the South, Who's Who in America, Outstanding Educators of America, and Contemporary American Writers. Dr. Woolfolk received an appointment as Admiral in the Texas Navy from Dolph Briscoe, and was recognized as Minnie Stephens Piper Professor for 1973. In 1992, he earned the American Historical Association's Award for Scholarly Distinction.

While serving on the Prairie View A&M University faculty, and as Professor Emeritus, Dr. Woolfolk continued to pursue his professional growth. He became a community resource through memberships and affiliation with such organizations and commissions as: Waller County Historical Commission, the Association for the Study of Afro-American Life and History, the American Association of University Professors, the Texas State Teachers Association, the Organization of American Historians, the American Historical Association, and the Panel of State, Local and Regional Research Studies of the National Endowment for the Humanities. Among his publications are *The Cotton Regency: The Northern Merchants and Reconstruction*, 1986-1880 (1958, reprinted in 1979), Negro Colleges, Texas (1962), Prairie View: A Study in Public Conscience, 1878-1946 (1962), and The Free Negro in Texas, 1800-1860 (1976).




