Conour Animal Shelter Allegations Given a Closer Look By Emma DeHerrera

Many people have come forward recently concerning the conditions of the Conour Animal Shelter. The Upper Rio Grande Animal Society is a non-profit organization that operates the no kill shelter here in Monte Vista, providing a temporary home for dogs until they are adopted. Because a number of allegations have been made against the shelter recently, the *Pirate Tribune* decided to investigate further after hearing from all sides.

On December 30, 2015, Anthony Guerrero of the Monte Vista Journal wrote the article "Animal shelter faces abuse allegations", part one of a series. Therein Guerrero claimed that "homeless dogs and puppies being housed at Conour Animal Shelter have been abused, neglected, ignored and generally mistreated by shelter employees, despite complaints to the Conour Board of Directors." He also wrote, "According to these allegations, the animals have slept in their own feces, gone without food and water, been subjected to an improperly handled Parvovirus outbreak and also have been yelled at, dragged, beat on the head, injected with used needles and their basic rights to comfort ignored." Former employee Brandi Branecky provided Valley Publishing with many documents, videos, pictures and voice recordings substantiating these claims. Branecky, a self-described animal advocate, eventually came forth on a Facebook page she created, explaining, "There were things going on at the shelter that I should've dealt with a long time ago." and "Instead of dealing with the actual issues, they would rather deal with the person reporting the issues." The board chairman, Jim Leist, immediately responded in disagreement, claiming Brandi was dismissed for being grossly insubordinate to him and the board's secretary. Braneky deactivated the page after the shelter created a new page.

Then, on January 6th, the Journal published

part two of the series because of claims of abuse and misconduct from Branecky, as well as from former and current volunteers. Both Branecky and the Board of Directors for the animal shelter were granted an interview. The Leist interview was originally Issue 5 March 17, 2016

scheduled for December 1st, but took place on the 22nd due to the shelter's attorney advising him not to proceed after reviewing Braneky's evidence. On the 22nd, according to the *Journal*, Leist stated, "I need you to understand that the vast majority of the problems at the shelter have been brought on by Brandi herself." He claimed her Facebook page was "not at all representative of true facts." Upon hearing that Valley Publishing had also discovered puppies in unsanitary conditions, Leist sent an email saying that the workers there had no volunteers at the time and have many responsibilities. Leist proclaimed, "We are one of the top 10 shelters in the state for cleanliness."

On two separate days in February Mrs. Jessica Castillo and Emma DeHerrera took last hour to venture around the shelter for a first hand look. Inside the shelter it seemed the dogs had been given adequate bedding, water, and food. None of the kennels looked messy, and the dogs looked relatively clean. The outside dogs also had food, water, and lifted beds. Mrs. Castillo noted, "The handlers knew the dogs and their character well." Although on our two trips volunteering as dog walkers we didn't find anything of concern, now that the shelter is on alert, it's not a surprise that conditions have improved (if, indeed, they were poor before); thus, we must all keep these allegations and their implications in mind in supporting the shelter.

Saguache County Jail Inmate Found Guilty of Rioting and Arson

Dickie Lopez has been accused of starting a jail riot on May 27th, 2015, at the Saguache County Jail and has been found guilty of three out of five counts, including riot in a detention facility, conspiracy to engage in a riot, first degree arson, assault, and criminal mischief. He was convicted for inciting a riot, first-degree arson and criminal mischief. District Judge Patrick oversaw the case which started on February 10th and finished around 1:30 pm on February 12th.

The proceedings revealed that the riot was supposedly aggravated when Lopez hung up a poster on his cell wall which read "red rum", which also reads murder backwards. Posters are not allowed in the prison so he was asked to remove it, after which Lopez says that he felt "disrespected". During breaks in the proceedings Lopez turned against his public defenders and protested against law enforcement. Saguache County confirmed that Lopez has a long history with the law and the prosecution introduced five witnesses: Prisoner Marty Martinez, who was present at the scene of the crime when the riot began, Saguache Sheriff's Deputy Wayne Clark, Saguache Sheriff Dan Warwick, former fire chief and dispatcher Ron

Gilbertson and Undersheriff Jim McCloskey.

Martinez attested that Lopez also spit in his face, which in the state of Colorado is considered assault when done towards enforcement personnel. Martinez also explained that without any help there was very little he could do to stop the riot. Deputy Wayne Clark, on the stand, stated that he arrived at the jail around 8:30 am when he saw fire coming from the building. He proceeded to enter and found a distressed Lopez pacing back and forth in the lobby. He then stated that he handcuffed prisoners and took them to an ambulance to be checked for smoke inhalation. He then followed them to the Rio Grande County Hospital in Del Norte and later helped transport Lopez to Park County Jail where Lopez asked him if "Warwick was mad that he burnt down the jail". Clark was then dismissed because, according to court rules, you can't use a statement after the actual event. Warwick was the next witness and told the jury that he arrived at the prison at around 7 am and discovered it to be in flames with the jailers rioting.

He said that he went into the jail after the incident, as well, and found damage from a melted air conditioner and damaged security cameras, in addition to damage from firefighters trying to put out the fire. He was then asked to confirm that he received a check from the insurance for damages adding to \$76,282 but he says that the actual amount came to about \$102,000. **Public** Defender Matthew Ferguson then gave a

lengthy demonstration of the bills from KW Construction and Renovation, the company who repaired the jail. Ferguson then said that the damage done to the jail wasn't enough to be considered first degree arson, in light of the video evidence.

Then the Saguache fire chief testified that he arrived at the jail around 7:15 to 7:30 am, at which time he was told that Lopez wanted to speak with him. The chief said that he tried his best to calm him down but Lopez kept saying that he was tired of the disrespect he received the night before as he paced back and forth. The chief was then asked if he gave Lopez the lighter he used to light the cigarette he offered him. He replied by saying no, that Lopez had taken a lighter from his waistband, which he, as fire chief, then confiscated

Next on the stand was McCloskey, who placed Lopez under arrest. He says during transport Lopez apologized for what he did and felt remorse.

Then, in the closing statements, Ferguson said that Lopez felt disrespected and that he didn't intend to start the riot or fire. The prosecution pointed out that the disrespect was irrelevant, however, because "you don't get to demand things in jail." Ultimately, Lopez was found guilty and will be sentenced on the charges March 29th at 1:30 pm.

Alamosa will be adding on a new K9 to help out with drug control in the San Luis Valley. The K9's name is Dax and he is from the Colorado Springs forest service. He is trained to detect drugs and aid in search and rescue missions. He is also trained for patrol, but the Alamosa police chief said that he will not be used for patrol at this time; he will only be used for drug work and search and rescue. The Alamosa police force is really happy to get a second dog because the K9 unit's current dog, Sammy, and his handler will get a break. The new dog that they will be receiving has been donated to them by the old handler and the forest service. The cost of the dog will be very minimal because the

Monte Vista School Board Discusses Senior Trip and Retirements By Emma DeHerrera

The February 11th school board meeting started off with the announcement that Abigail Sanchez, president of the senior class, put in a request for an overnight senior trip, which was approved as an exception to board policy. The Board also accepted the retirement resignations of Mary Vigil and Jerene Wilkinson. The board also approved Maria Martinez as a guest teacher (one year sub authorization) and Daniel Gallegos as a classified guest employee (a bus driver). During his superintendent's report, Mr. Robert Webb spoke about his recent exchange trip to Mexico, gave an update on the Curriculum Loft matter, discussed a transition plan for the staffing changes in the administration office, gave a budget update, and reported on SCAP. In regards to school safety, Mr. Webb reported on the new plan and highlighted points from the Claire Davis study. The board also approved several policy revisions, a policy repeal, December financial and quarterly reports, and the minutes from the two previous meetings. The Board then heard reports on BOCES, the Education Foundation, and city/district conversations. They also had follow-up comments and questions in regards to the principal reports. Soon enough, the Moose started giving their all and scored 9 points on Monte's defense. But then Monte dropped an easy 12 points on Alamosa. In the final quarter the Pirates had no mercy and attacked the Moose with their striking defense. But the Moose sort of kept their cool and continued to play, even though Monte had an amazing defense that supported the sharp Monte offense. At the end of the game the Pirates won 45-35, thanks in great part to the leading scorers: Danielle Chacon (16 Points), Abigail Sanchez (8 points), Lexi Wingert (8 points), and Terrise Sanchez (5 points).

There were five groups, all teaching about different properties of science, including inertia, air pressure, and chemical reactions. The Fun Night was made so all of the little kids could go out after school with their parents and watch some interesting experiments. Our Mesa Science sponsors who run the club are Eric Hotz and Gary Wilkinson. The sponsors at Bill Metz are Annette Montoya and Kellyn Ross. The club's main student boss is Presley Garcia, number 30 on the court but number 1 in Mesa's hearts, as he is our one and only president.

The night, overall, went very well and the kids seemed to enjoy our presentations. Prior to the event, we all met up at the high school to get all of our materials together and practice our experiments. Then we proceeded to five different rooms that were set up in Bill Metz. Each room had three different experiments. I

myself was not able to go into each of the rooms and check out all of the experiments, but the room I was in was all about air pressure. We demonstrated how airplanes get lifted off the ground by using a pop can and a glass beaker. Blowing into the beaker would cause the can to shoot out of the beaker. The next demonstration showed how strong air is. We used a straw to stab through a whole potato by putting our thumbs on the back of it and letting the air push through it. Lastly, we had a demonstration with water. We filled up a water bottle with water and poked multiple small holes in it, but no water would come out unless the lid was taken off. About fifty kids and thirty parents came for Family Fun Night to see these science demonstrations, which I would consider a success.




Kali Wallace's Shallow Graves Takes Readers Deep Into the Life of Breezy By Violet Swope

Social Anxiety is a Serious Issue in Schools By Lily Query


Social anxiety, also called social phobia, is an anxiety disorder in which a person has an excessive and unreasonable fear of social situations. Anxiety and self-consciousness arise from a fear of being closely watched, judged, and criticized by others. A person with social anxiety disorder is afraid that he or she will make mistakes. look bad, and be embarrassed or humiliated in front of others. The fear may be made worse by a lack of social skills or experience in social situations. The anxiety could even escalate into a panic attack. As a result of the fear, the person endures certain social situations in extreme distress or may avoid them altogether (if possible). In addition, people with social anxiety disorder often suffer from "anticipatory" anxiety—the fear of a situation before it even happens—for days or weeks before the event. In many cases, the person is aware that the fear is unreasonable, yet is unable to overcome it. People with social anxiety disorder suffer from distorted thinking, including false beliefs about social situations and the negative opinions of others. Without treatment, social anxiety disorder can negatively interfere with the person's normal daily routine, including school, work, social activities, and relationships. People with social anxiety disorder may be afraid of a specific situation, such as speaking in public. However, most people with social anxiety disorder fear more than one social situation (apa.org).

Supreme Court Nominee Controversy Continues By Derek Medina

President Barack Obama has said that Republicans have no constitutional grounds to refuse to vote on a Supreme Court nominee. Obama's attempt to fill the seat of Justice Antonin Scalia will test if the Senate could function with the Republicans opposing. The Chairman of the Judiciary Senate, Charles Grassley, said he might be open to Obama's yet-to-be named nominee, though a "short list" has already been leaked. Obama stated that he and the senators need to do their jobs in responsibly filling the vacancy. Many politicians have said Obama should leave the choice to the next president. Obama has disagreed and says he will put forward a replacement. Democrats support him by saying he has every right and constitutional duty to fill vacant slots on the court until he is no longer president. It is a hard and slow process to get a new candidate in there during campaign season, though. The Republican party is still searching for a strategy to not let Obama pick a new nominee.

In "Here's who should replace Antonin Scalia" CNN reports that Obama can nominate anyone to replace Justice Scalia according to the constitution. The Senate can reject any candidate and does not have to have a reason. When the president is on the opposite party of most of the Senate, the nominee is turned down moderately. Three nominees are currently possible: The President can nominate a moderate, can appoint someone to the court on a recess selection, or he can appoint a leading legal mind. Further complicating the issue, Politico points out in "McConnell throws down the gauntlet: No Scalia replacement under Obama" that McConnell, the Senate majority leader, said the Senate should not confirm a replacement until after the 2016 election, shocking White House officials. McConnell also believes the American people should have a voice in the selection. However, according to Politico, Scalia's wish was for Obama to pick the next nominee. Though there are certainly disparate opinions on this issue, leaving the Supreme Court with a vacant seat for so long would be a big mistake and an embarrassment.


Easter Untold: The Story of the Holiday, Past and Present

The name "Easter" has roots in paganism, though much of the history and meaning behind the holiday is Christian in nature. The holiday's name isn't used in the original Scriptures or in the bible referring to the death and resurrection of Jesus Christ, which is now the religious basis of the day, as well as its preparatory season, Lent. Because of this, Christians often use the term "Resurrection Sunday" to distinguish between the word's pagan roots and the religious significance of Easter. Easter came from Eastre, the Teutonic goddess of Spring, although the origin of the name and the goddess are far more ancient, beginning not long after the biblical flood. In the biblical flood Noah built his ark upon God's request to save humanity by saving himself and his family.

The Easter bunny and egg both have interesting backgrounds, as well, though their connection to either the goddess or the biblical flood is not immediately apparent. The Easter Bunny is actually a sexual symbol of fertility. Many different parts of the world associate the rabbit with periodicity, both human and lunar. The Mother Goddess Easter, Semiramis, is also associated with the Moon, so basically the Easter bunny symbolizes the Mother Goddess and fertility. The Easter Egg also symbolizes the Goddess: "The egg was a sacred symbol among the Babylonians. They believed an old fable about an egg of wondrous size which was supposed to have fallen from heaven into the Euphrates River. From this marvelous egg—according to the ancient story—the Goddess Astarte (Easter) [Semiramis], was hatched. And so the egg came to symbolize the Goddess Easter" (Woodrow 152-153).

Today, during the Easter holiday Americans spend \$1.9 billion on

Easter candy, most of it packed into those symbolic little eggs. That's the second biggest candy holiday after Halloween. 70% of Easter candy purchased is chocolate. 76% of Americans think the ears of a chocolate bunny should be the first to be eaten, though the bunny is actually a symbol of fertility, just like the eggs so popular at egg hunts hosted by churches and community organizations nation wide. Today's artificial dyes are very different from the original egg dyes, which were made out of natural items like onion peels, tree bark, flower petals, and juices. Egg hunts evolved into egg shaped candy and décor, as well. The tallest chocolate Easter egg ever was made in Italy in 2011. At 10.39 meters in height and 7,200 kg in weight, it was taller than a giraffe and heavier than an elephant. In addition to chocolate, Americans buy more than 700 million marshmallow Peeps during the Easter holiday, which makes Peeps the most popular non-chocolate Easter candy.


