Employment

- 8,857 employees (wood manufacturing).
- Total payroll = \$348,700,654 annually. Average weekly wage = \$757.
- Ranked as 8th largest wage supplier in Manufacturing sector. (6.2% of total mfg)
- Note that Furniture Manufacturing accounts for an additional 6.2% of all manufacturing wages.
