

## Arizona Tax Credit Donation

Extra-Curricular Activities



You can help Chinle students, from preschool through high school, have the greatest academic success by giving them the opportunity to participate in extra-curricular activities, including sports, field trips and more. The State of Arizona allows each individual tax payer to donate up to \$200. Donate up to \$400 maximum if you are married filing a joint tax return to a Chinle Unified School of your choice and deduct that amount from your state income taxes through a tax credit.

Legislation passed in 2015 allows the donor to donate up to April 15<sup>th</sup> of each tax year. The dollar for dollar credit on your taxes will either help reduce your overall taxable income and/or produce a dollar for dollar return on your tax return. In addition, extra-curricular programs at Chinle Unified School District will be supported through your donation.

\*Corporate and/or business checks are not eligible. A.R.S. § 43-1089.01(G)(2)(d) and A.R.S. §15-342(24) defines extracurricular activities as schoolsponsored activities that supplement the school's educational program and require enrolled students to pay a fee in order to participate. Please check with the CUSD Business Office if you have questions about specific program eligibility.
