- Mrs. Kiesler reported attendance at a Federal Relations Network in Denver. There will be a questionnaire mailed to all federal office candidates. The results from the questionnaire will be shared with all School Boards and CASB members. There was no report on legislation at this time.
- Mr. Butler reported attendance at a Stakeholders meeting in Denver. Mr. Butler will attend the next meeting on September 20 to review subcommittee ideas.
- Mrs. Enos-Martinez reported student registration at FMHS was well-organized. Mrs. Enos-Martinez expected a sixty to ninety minute registration process and was complete in fifteen minutes. She expressed appreciation for the polite environment and efficient registration process.
- Superintendent Schultz thanked the Board for their reports.

**F. LEGISLATIVE REPORT**

- Nothing new to report at this time.

**G. AUDIENCE COMMENTS**

- Mr. Butler read the guidelines for meeting attendees to address the Board and asked the Board Secretary if anyone had requested to speak. No requests were received.

**H. SUPERINTENDENT'S REPORT**

- Superintendent Schultz reported staff returned back to work today with high energy. Staff development and classroom preparation will take place this week. Enrollment projections were discussed. Superintendent Schultz informed the Board, District 51 performance frameworks have been received. These frameworks will be shared with the Board at the September Work Session.

**H-1. Instructional Update: Mr. Jon Bilbo, Dr. Jody Mimmack, Ms. Samantha Long**

- Mr. Bilbo, Grand Junction High School Principal, Dr. Mimmack, Fruita Monument High School Principal and Ms. Long, Director of Colorado Legacy Foundation shared information with the Board:
  - All four high schools in Grand Junction applied for the Legacy Grant.
  - There was a rigorous and difficult evaluation process. Eighteen schools in Colorado applied, with seven being awarded the Legacy Grant. Mesa County Valley School District 51 was the only school district in the State of Colorado to be awarded the Legacy Grant at two schools.
  - This is a math and science teaching program supported by the National Math and Science Initiative. The goal is to help students' graduate "college ready".
  - The program creates an incentive to participate in Advanced Placement classes.
  - One of the targets is to increase African-American and Hispanic students' participation.
  - During the summer, teachers from FMHS and GJHS participated in staff development.

- The Board discussed ensuring support for additional AP classes like Spanish, German, French, Art, Social Studies, etc. Mr. Bilbo and Mrs. Mimmack reported increased interest in all AP classes. Mr. Bilbo expressed staff enthusiasm for recruitment and participation in all AP classes.
- Superintendent Schultz reported all four high schools applied for this Grant. He stated all four high schools were exquisite examples of how to be innovative in difficult financial times. The Board and Superintendent applauded staff and teachers for doing what is best for kids.

H-2. Chamber Forum Discussion:

- Superintendent Schultz shared plans for Ms. Diane Schwenke and Mr. John Hopkins to come to the Work Session in September to discuss planning taking place at the Chamber Forum. Mr. Butler and Mr. Mikolai attended Chamber Forum meetings and are excited about the community and school district coming together to support kids.
- The Board expressed their support and gratitude to the Chamber for their partnership.

H-3. Nutrition Services and Wellness Program Discussion: Mr. Dan Sharp

- Mr. Sharp discussed information shared with the Board at the August 3 Work Session. He presented proposed changes in pricing for secondary school lunches. Mr. Sharp explained the request for the increase would help balance the budget.
- The Board thanked Mr. Sharp for his dedication to students of District 51.

H-4. Financial Update: Mrs. Melissa Callahan-deVita

- Mrs. Callahan-deVita reported District 51 had sound fiscal practices and unexpected revenue of property taxes. The District ended the 2009-2010 school year in a better financial place than predicted. Mrs. Callahan-deVita also reported Nutrition Services decreased their annual loss. The medical insurance fund ended the fiscal year with lower than anticipated claims.
- Mrs. Callahan-deVita is planning to conduct focus groups with community leaders and parents to discuss potential budget reductions for the next budget process. The goal of the district is to be as transparent as possible and communicate clearly with the Board, staff and the community.
- Superintendent Schultz thanked all schools for continuing to be diligent. The Board thanked Melissa for her work.

H-5. Final Expulsion Report

- Superintendent Schultz shared the numbers from the final expulsion report of the 2009-2010 school year. The district ended with lower numbers than the previous year. Superintendent Schultz applauded schools for utilizing data to help respond to situations in different ways.

*2010 Top Composite Score on ACT*

Sean McKee, an upcoming senior at Fruita Monument High School, earned a top composite score of 36 on the ACT test he took in the spring.

Nationally, while the actual number of students earning a composite score of 36 varies from year to year, roughly one-tenth of one percent receive a top score. Among test takers in the high school graduating class of 2009, only 638 of nearly 1.5 million students earned a composite score of 36.

ACT test scores are accepted by all major U.S. colleges, and exceptional scores of 36 provide colleges with evidence of student readiness for the academic rigors that lie ahead. While Sean is a young senior, he's keeping his options open for his post-graduate plans. Overall, his biggest priority is to "always be exploring and never let myself get stuck in a rut of other people's expectations."

Andrew Duff, an upcoming senior at Grand Junction High School, was one of two high school boys chosen to represent the state of Colorado at the 2010 Boys Nation program in Washington, D.C. Only two delegates are elected from each Boys State program, making Andrew one of 98 boys in the nation who attended this summer's 64<sup>th</sup> American Legion program. (Hawaii does not have a Boys State.)

Between senate sessions, party conventions, and elections for a president and vice president, the delegates visited prominent memorials and historical sites around Washington such as the White House, the Arlington National Cemetery, the Supreme Court and the National Mall. The boys also enjoyed a dinner at the Maryland Greenbelt Legion Post 136 with American Legion National Commander Clarence Hill as the keynote speaker.

The purpose of Boys State and Boys Nation is to simulate American Government and delegates learn the proper method of handling bills, according to U.S. Senate rules. Participation in the political process is emphasized throughout the week, including organization of party conventions. In the Boys Nation senate there are four committees, and each one has a variety of bills for consideration. Andrew was on the committee overseeing agriculture, appropriations, and armed services and banking bills.

The final afternoon of Boys Nation was scheduled to be spent at the White House where the boys met President Obama and had their picture taken with him.

Since Boys Nation began in 1946, a number of its graduates have been elected to public office, including presidents, congressmen, state governors and state legislators. Many others have been inspired to work for the campaigns of individuals seeking public office. Andrew hopes to spend his post-graduate days serving his country as well. He is a candidate for all of the service academies and has recently received his Letter of Assurance, reserving him a cadetship for the Class of 2015 at West Point.

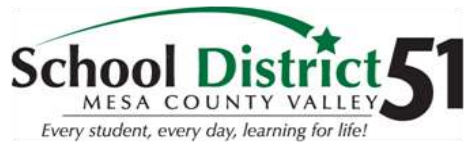

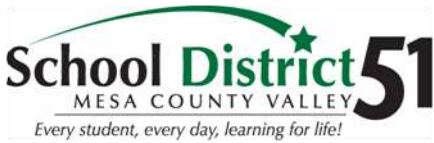

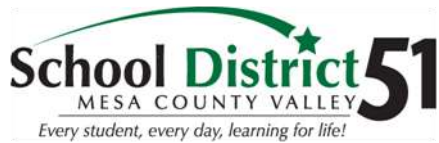

WHEREAS, the current status of the school lunch program was then reported, indicating the 2010-11 Federal reimbursement meal price rates have not kept pace with increasing food and labor costs. The average cost per meal for a secondary student is \$2.81 at Middle Schools & \$3.23 at High Schools. As a result overall expenditures for food services have exceeded revenues; and

WHEREAS, the Mesa County Valley School District 51 Food Service Department is intended to be a self-sustaining, enterprise program; and

WHEREAS, the administration requests approval to eliminate the lower tier \$2.25 of the \$2.25 to \$2.75 current pricing at all secondary schools to set pricing of \$2.50 at Middle Schools and \$2.75 at High Schools. Price change has no impact on Free/Reduced Lunch students. Secondary price change will allow the food services program to balance its budget.

THEREFORE, BE IT RESOLVED the Mesa County Valley District 51 Board of Education adopts the proposed food service secondary meal price increase requested by the administration for the 2010-2011 school year.

WHEREAS, the Colorado Constitution mandates:

1. That the general assembly shall establish and maintain a thorough and uniform system of free public schools throughout the state; and,
2. That the general assembly shall provide for the organization of school districts to be governed by locally elected boards of education that are vested with the control of instruction in the public schools of their respective districts; and,

WHEREAS, on October 19, 2009, the Colorado Supreme held in *Lobato v. State of Colorado*:

1. That the Education Clause of the Colorado Constitution contains a substantive mandate to the general assembly to assure that thorough and uniform educational opportunities are available in every school district and that every school district has the control necessary to implement the mandate at the local level; and,
2. That the state's public school finance system must be rationally related to fulfilling the constitutional mandate that the General Assembly establish and maintain a "thorough and uniform" system of free public schools throughout the state; and,
3. That it is the responsibility of the judiciary to review claims that allege a failure by the general assembly to fulfill the mandate of the Education Clause; and,
4. That Colorado school districts may participate as plaintiffs in the pending public school finance litigation; and,

WHEREAS, *Lobato v. State of Colorado* is now remanded to the district court for trial on the merits; and,

WHEREAS, this Board of Education is authorized and charged by law with the responsibility to provide an educational program that meets the high expectations of the students, parents, and taxpayers within the District; and,

WHEREAS, the general assembly has enacted legislation establishing a system of educational accountability based upon goals, objectives, content standards, standardized testing, assessment, school accreditation, and school accountability, which system has also incorporated the federal No Child Left Behind Act; and,

WHEREAS, this system has imposed increased expectations and obligations upon local school districts, which include progressively more demanding standards, all under threat of state and federal

sanctions, up to and including privatization of local schools; and,

WHEREAS, neither the State of Colorado nor the federal government has provided adequate funding to permit local boards of education to meet the constitutional mandate to control instruction in their schools, the legislative mandate to achieve certain standards of student performance, and the expectations of the communities which they serve; and,

WHEREAS, the Colorado public school finance system is not designed to assure the level of funding necessary to provide the programs and services guaranteed by the Colorado Constitution and to meet the academic standards to which all school districts and their students are held accountable; and,

WHEREAS, the general assembly has failed to fund categorical and other programs intended to provide badly needed support and to meet the requirements of federal and state law for at risk student populations, low income families, second language learners, and special education students, all of which further impacts the educational opportunities available to all students; and,

WHEREAS, the general assembly has failed to demonstrate the commitment or ability to provide for and fund an adequate and equitable system of public education that meets the standards of the Colorado constitution; and,

WHEREAS, the school districts and their boards of education have special constitutional and statutory interests that are substantially independent of the state board of education, the general assembly, and the State of Colorado; and,

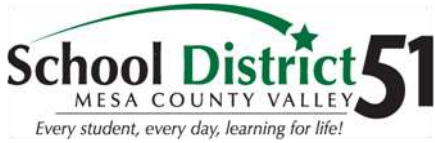
WHEREAS, the Colorado Association of School Boards (CASB) and the Colorado Association of School Executives (CASE) governing boards have strongly endorsed the Colorado school finance litigation;

THEREFORE, IT IS RESOLVED, that the Board of Education endorses and supports the Colorado school finance litigation, known as *Lobato v. State of Colorado*.

**Resolution To Form District 51 Foundation**

WHEREAS, the Board of Education believes the District will likely face significant budgetary pressures in the years ahead, and the Board of Education believes that revenue from federal, state and local government sources will not be sufficient to fully fund District operations and programs or to otherwise meet the educational needs of students; and

WHEREAS, fund-raising activities could provide grants, donations and other alternative resources to supplement precarious public funding and help support and maintain District programs, projects and initiatives; and

WHEREAS, there is currently no organization existing to encourage, coordinate and facilitate fund-raising for such purposes, or to foster broad-based community support for public education in the Grand Valley; and

WHEREAS, the administration has proposed to organize a private, non-profit corporation to be named the “District 51 Foundation,” to raise funds on a tax-exempt basis for capital projects and key performance programs and initiatives relating to public education in the District and to partner with other public and private institutions to improve overall community involvement among District educators, parents, students and community members toward the common goal of providing quality public education for District students; and

WHEREAS, the District 51 Foundation would be governed by a board of trustees composed of community members and designated representatives from the District; and

THEREFORE, BE IT RESOLVED, the Board of Education approves the formation of the “District 51 Foundation” for the educational and charitable purposes identified above, provided such purposes shall be construed to be in furtherance of such exempt purposes as are permitted by Section 501(c)(3) of the Internal Revenue Code of 1986, as amended. FURTHER RESOLVED that the Superintendent is directed to take the steps necessary to organize and establish the “District 51 Foundation” as a non-profit corporation qualifying for tax exempt status under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended.
