XIII. Public Input: Pursuant to Board Policy #1550 Public Participation in Board Meetings Public Input shall be held to a maximum of 1 hour and will provide an opportunity for any Board Member, administrator, staff member, student, or patron to raise issues of interest. The Board will receive such input without comment, except to ask germane questions of those speaking. Comments should be limited to three (3) minutes. The Board will take no action relative to any items during the meeting, but may direct the Superintendent to consider such an item at a subsequent meeting. There was not any public input at this meeting.

XIV. Administrative Reports

A. High School Construction Report - Brad McKinsey, Owners Representative

Chairman Jenkins invited John Pymm, in absence of Brad McKinsey, to give the Thunder Ridge High School Construction update. Mr. Pymm showed a drone video of Thunder Ridge HS. Highlights were site work including sidewalks and paving finished and landscaping with irrigation being installed. Tennis courts are ready and grass is growing in soccer and practice fields. Exterior siding is soon to be finished. Inside the building the main offices, media center, theatre lobby are finished. Theater and balcony seats are placed and curtains and orchestra shell are being hung on stage. Most of the classrooms are finished and custodians are hard at work cleaning up after the construction workers. Common area benches are being installed and the elevator is working. The bleachers in the main gymnasium are being installed. The project is 95% finished! An open house and ribbon cutting event are being planned right before classes start.

B. Special Education Elementary Growth Workshop Report - Julian Duffey, Director of Special Services

Chairman Jenkins invited Julian Duffey to give the report on how special education is being affected by the increase of student growth. Others who presented were Rex Miller, Director of Special Education and Developmental Resource Room (DRR) teacher from Summit Hills, Bridgett Cress. Mr. Miller informed the Board on the basic facts of the special education programs: there is always more to learn, legality of programs consistently growing and changing, IEP balancing, programs are full with an average increase of 100 students per year, collaborating with other districts and researching innovative ways to help with growth. The first workgroup consisted of 19 parents, teachers, Board members, and administration which represented over 300 years of educational experience and the spring workgroup consisted of 32 people which represented over 450 years of experience. Areas of focus included keeping students together and not segregated from the general student population, consolidating programs to help students intertwine medical and academic needs, PLC collaboration between teachers is needed, and maintaining IEPs. Bridgett Cress discussed the concern of the growing number of students with delicate issues and severe needs. She stated programs are growing, intervention is needed early at the preschool level and that building a larger elementary school with integrated programs is best to meet the educational, physical and behavior needs for students, is most cost effective and supported by parents.

C. Report on the State of the District - Sheryl Gittings, Director Maggie's Place Learning Center

Chairman Jenkins invited Director Sheryl Gittings to present on Maggie's Place, an afterschool and summer child care program. Ms. Gittings informed the Board that Maggie's Place has been involved with District 93 since last year and currently provides after school care for over 100 families. This summer's camp programs involve 79 families. The program meets in the Ammon, Falls Valley and Discovery elementary schools. They provide daily snacks, crafts, and tutoring after school and also provide child care for in-service days, winter and spring breaks. Summer camps take advantage of the Lunch at the Park program offered by the District Food Service department. District employees receive 50% discount on any child care costs. Maggie's Place has a revenue shares program set up where the District receives 5% of their revenue per year.

D. Proposed Policy for Initial Consideration - Marjean McConnell

Chairman Jenkins invited Marjean McConnell to present policy for initial consideration. She stated these policies have been updated to current practices.

Chairman Jenkins invited Guy Wangsgard to present 2018-2019 budget. As required by law, both the fee hearing and the budget hearing were advertised in paper. Mr. Wangsgard reviewed the summary of the budget. Once approved by the Board, the budget is submitted to the Idaho State Department of Education. State law requires 5% of the budget set aside for contingency expenditures. Contingency amount is greater this year since the budget is greater this year. The floor was opened for any public input. Hearing none, Chairman Jenkins asked for a motion to approve the 2018-2019 budget.

MOTION: Chad Dance moved to approve 2018-2019 District Budget. Amy Landers seconded. The vote was 5 in favor with 0 opposed and 0 abstentions. Motion carried.
