Dear Secretary Bunting:

I am a member of the Board of Directors of Odyssey Charter School. I am a member and Past President of Wilmington Chapter #95, the founding organization of the school. But I am also a papou, a grandfather, of two boys who attend the school. I am writing this letter of support for the precepts and ideals of the school as their papou.

I left the area in 2005 to work in my field. This was a pivotal time in the development of the school. I followed closely as many friends, good, honest, hard working people gave of their time, talent, and treasure to make their dream of a school steeped in the ideals of ancient Greece, the basis of our great country, a reality. They took baby steps, but in 2006, their efforts paid off with the first class of the school. Those students are set to graduate this coming June. How proud they would be to see how far their idea has come!

My children were well on their way in their careers by then. But I have two grandsons. We were living in Massachusetts when our daughter told us she applied for the lottery for our oldest grandson to enter the school. I was so impressed by the early trajectory of the school's growth that I was most excited of the prospect of his entering Odyssey. But all we could do is wait.

Then, one day in early 2010 I believe, I was heading to my car at the parking garage to go to an appointment. My daughter called. That moment is etched in my mind forever. Our grandson was accepted and was starting at Odyssey that September!!! I was so delighted that I immediately drove to church and lit a candle of thanksgiving! That moment was that impactful to me.

Over the years, I have seen my grandson grow and evolve. A couple of years later, he was joined by his brother. The school has had an impact on each of them in different ways. But the one thing that is consistent is helping them grow as students and citizens of the world. These well-rounded experiences they would not have had should they have gone to their local school.

There is parental pride. But the pride of a papou or yiayia, a grandfather or grandmother, is without equal. I attended their holiday concert to see my grandson sing. Not only was I proud of him, but also seeing little black, brown, yellow, white, and red children joining together to sing Greek Christmas carols. Where else but Odyssey?

Then, I experienced their Ellis Island recreation as they went through the stations of that bustling port of entry. Where else but Odyssey?

Then their coming home and speaking Greek from their immersion classes. They were able to understand the roots of many English words they use in school from the Greek. Where else but Odyssey?

The students in the chorus, singing the Greek and American national anthems at a flag raising on Greek Independence Day at Freedom Plaza in Wilmington with the Governor of Delaware and Mayor of Wilmington present AND again leading the Greek Independence Day Parade up the Parkway in Philadelphia, Where else but Odyssey?

Finally, taking my grandsons to Greece last year to the places my grandfather took me on my first trip there. Photos at the same spots. Meeting their relatives. Knowing the history of the country and its mythology. I have taught them as much as I can. But they learned a lot in school too. That is a luxury I did not have growing up. They were telling us about things they were witnessing first had, but had learned about in school. Where else but Odyssey?

As a papou and friend of many of the Founders of the school, I do not want to see the school veer off its course. It truly scares me that all that has been developed over the past 13 years will be lost should Odyssey be forced to change its governance and focus.

Can it be better? Of course! Any organization, be it government, business, a school, or even a family, needs tweaking from time to time. But to mess with success by changing the governance which will change the mission and vision of the school will make Odyssey, I fear, "just another school."

It has come too far to become "just another school." My friends, many of them now departed this life, gave their all to make Odyssey the special school that it is. I want the "where else but Odyssey" statement to come to mind whenever we speak of Odyssey. Don't make it become "just another school." Tweak it to make it better. But I implore you, please retain the AHEPA majority. I fear deleting that majority will change the mission and vision of the school as intended by its Founders.

My term on the Board of Directors of the school is limited. My membership in AHEPA is annual. But I will ALWAYS be a papou!!! And a papou only wants what is best for his grandchildren!

Dear Charter School Accountability Committee Members,

We, the undersigned, **George and Elaine Righos**, active members of the Odyssey Charter School community and also great-grand-parents of three students attending now OCS, (the oldest of whom will be a Junior this year), We are writing this letter in support of the school, the current board, administration, staff and students and recognize the foundational and mission-critical support of AHEPA.

As a 53 year Life member of AHEPA and one of the founders of OCS, (I must include my spouse, Elaine, who has been very supportive of my involvement in the creation of OCS). She is the one who had to cope with the endless hours of my absence from our family life, while I was attending training for Payroll, Human Resources, Accounts Payable, and Accounting reporting. These are the same training activities approved, provided with required attendance by DOE employees depending to their assignment), and then managing for the first 12 years the school's business activities gratis, to fulfill my commitment to AHEPA.

Both of us are long-time members of the AHEPA Family, and our contributions go far beyond our involvement with OCS. I am a recipient of the Lifetime Achievement award of AHEPA, not just for being involved with OCS, but also for being actively engaged in managing the AHEPA 5th District as District Governor 2001, (Dist.5 is comprised by 20 Chapters at N.J. and Delaware), and the AHEPA 5th District Cancer Research Foundation, which I served for 4 years as Board Vice Chair. This Philanthropic organization has actively supported cancer research, with grants to cancer researchers amounting in excess of One Million dollars. Beneficiaries of grants are The Fox Chase Cancer Research Center, the Helen F. Graham Cancer Center – Christiana Care Health System, the N.Y. Presbyterian Hospital, and many other prestigious institutions.

Other activities supported by AHEPA are Scholarships to High school graduates, encouraging further education, and Dogs for Wounded Warriors.

AHEPA was formed on July 26, 1922, to assist legal immigrants from all countries against discrimination by the KKK, and help them become naturalized productive citizens of the United

States of America. In its almost 100 years of active service to community, AHEPA's leadership, this non-political, non-sectarian and non-profit organization, has been recognized for its services at an annual reception of the White House for the past several decades. AHEPA in turn is honoring the members of Congress at a Biannual Banquet for the U.S. Congress. AHEPA's precepts of Hellenism, Education, Civic Responsibility, and Individual and Family Excellence, all aim towards instilling good American citizenship to its members and those who hope to become citizens.

The AHEPA efforts have been recognized by our Federal government as early as the 1940s when it became known that the organization sold the most U.S. WWII Bonds. As a result, President Harry Truman and later Pres. Gerald Ford became active members of AHEPA. The list of members today includes a large number of U.S. Congressmen and U.S. Senators, who followed the example of our own past U.S. Senators, William Roth, and Caleb Boggs.

AHEPA's humanitarian and educational contributions in the span of 97 years are too numerous to describe in the limited space of this letter. It should suffice saying that the principal values asked to be followed by its members are all non-profit related, such as the seventy AHEPA Senior Citizens Housing projects throughout the country. Those projects, provide housing to over 6000 seniors citizens and are open to local communities. It must be noted that the people served not necessarily of Greek background.

I made this introduction of AHEPA with the hope that the role of this organization and its important effect upon OCS will become more visible.

Although the school has a fantastic record of success in the areas of enrollment, academics, Greek programming, and school leadership, there have been complaints raised about AHEPA, the members of the OCS Board and by specific individuals. The actions alleged in the Public Integrity Commission findings sound inappropriate, and the public and community view of those actions have been made worse through the media and lack of communication by the OCS Board. If I may, I would suggest a review of other charter schools of this state may be necessary, before coming to a conclusion of personal integrity violations by OCS. It appears that there are for-profit organizations which support schools in the state of Delaware, whose employee-representatives possibly may have influence on school governance.

We believe the actions taken by the OCS Board were made in good faith, having consulted with lawyers and experts, in the belief that they were both compliant with the law and, more importantly, the right decisions for the long-term benefit of the school and the students. We believe that those complaints addressed by the proposals in the OCS Board's answer to the Public Integrity Commission, and we believe the CSAC and the Board of Education should accept those proposals.

We firmly stand by the mission and vision of this outstanding school as it was laid out by AHEPA.

OCS has our unwavering support – we trust the teachers and the administration with our children, and we trust the OCS Board as it is currently configured to manage the future of the school.

We also believe that there has been insufficient focus on the incredible support provided to the school by AHEPA and its members who have donated time, money, energy, and significant resources to OCS. Without those contributions, the school would not even exist, let alone be the success that it is today.

The contributions from AHEPA have had a positive impact on and outcomes in every aspect of the school –

- Strategic planning, including the vision, the mission of the organization and support of its unique educational model;
 Networking with multiple strategic partners that aid the school and creates unique international opportunities for the students and the entire Odyssey community; Ongoing commitment from AHEPAns who serve on the board and volunteer for the school in other ways;
- Organizational sustainability, continuity and ongoing commitment from AHEPAns to serve on the board and volunteer for the school in multiple different ways;
- The acquisition of the campus and its facilities including the foresight to designate two buildings to serve as ongoing sources of rental revenue for the school's operations;
- The money provided to start the school and current allocation of needed resources to support and operate Odyssey and its newly acquired campus; and
- Ongoing fundraising to retrofit the school buildings and create new educational spaces.

When we chose Odyssey for our children, our decision was based on the Greek language and mathematics model, with an understanding of the contributions the Greek culture has made to Western civilization and the United States. What we have found at Odyssey is so much more than that in large part because of AHEPA and the efforts spearheaded by Dimitri Dandolos. AHEPA and its members have not overtly publicized their contributions, choosing, instead, to allow the results to speak for them. We think those who are complaining about AHEPA's role in the governance of the school are not aware of many of the things that AHEPA has done for the school.

Without AHEPA, there would be no place for those academic opportunities to flourish. Examples of AHEPA contributions to the campus and facilities listed in Appendix 2 provided to DOE attached to a previous communique.

The academics and the campus require money to operate beyond state funding. In addition to helping the Odyssey get teachers from Greece paid for by the Greek Ministry of Education and other cost reduction activities, AHEPA and AHEPAns have been critical to the fundraising that is essential to the school. Examples of AHEPA donations and monetary contributions to Odyssey listed in Appendix 3 also submitted to DOE by the OCS board.

There is no other entity that has made such a commitment to the school or has the resources of this almost 100-year old philanthropic organization to continue such sustained, innovative and highly productive efforts on behalf of Odyssey. Our primary concern as members of the Odyssey community is that if AHEPA leadership is changed or removed, these connections will be lost.

We ask that you strongly consider the overwhelming contributions of AHEPA and its members for the benefit of Odyssey when completing the formal review process. The results for the last 14 years speak for themselves. We believe that it is in the best interests of the students and the school for you to accept the proposals made by the OCS Board allow AHEPA to retain its majority on the board.

Although the Committee's report lists "potential violations of the school's charter" (emphasis mine), it is clear that the Committee has already made up its mind that the allegations are true.

It is very upsetting that AHEPA has been vilified and accused of financially profiting from the school. AHEPA was founded in 1922 in Atlanta, Georgia to teach English to recent Greek immigrants and to fight discrimination and hate of the Ku Klux Klan. Wilmington Chapter #95 was formed the following year. AHEPA has grown to be the largest association of American citizens of Greek heritage and non-Greek Philhellenes. AHEPA and its sister organization, the Daughters of Penelope have given back over the years by funding hospitals, cancer research, battered women's shelters and affordable housing. AHEPA National Housing Corporation is one of the largest providers of affordable housing for the elderly with 95 apartment communities in 21 states.

With the formation of the Odyssey Charter School, Wilmington AHEPA Chapter #95 entered a new charitable arena. The \$60,000 seed money, that the local chapter provided, was literally earned by the sweat of the members. This Education Fund was built up over a period of years, from the sales of Greek foods at local events like arts festivals and community gatherings. Since then, the local chapter and its members have provided hundreds of thousands of dollars of support and tens of thousands of hours of volunteer time. Additionally, AHEPA members' connections with major universities, the Greek

government and AHEPA National have brought huge resources to the school. With certainty, I can say that, since the school's inception, funds have flowed in only one direction – from AHEPA to the school.

The Charter Schools Accountability Committee's primary recommendation "that the majority of the OCS Board will be comprised of individuals who are not members of the AHEPA family organizations" will definitely destroy the synergy and momentum that has been building since the school's inception. The leadership of AHEPA on the board of directors has been essential to the school's success. I, personally, seriously question the motivations of the Committee's members. Had the achievements of the Odyssey Charter School been made through the efforts of a different organization, representing a different minority group, they would have been applicated rather than attacked. The issues that have been identified would have been resolved cooperatively, as issues have been resolved at other charter schools and school districts.

As a Certified Public Accountant and as a Certified Government Financial Manager, I am not blind to the fact that some serious issues may exist. Allegations of potential misappropriation of funds, violations of laws and violations of policies are disturbing to me professionally. Although the actions in question were done with the advice of legal counsel and the Charter School office, they are disturbing to me personally because they involve two organizations to which I have devoted significant volunteer efforts. Perhaps, because I have worked with all sides involved in this dispute, I might be in a better position to see the situation and a resolution clearly.

Certain officials have been calling for an audit of the Odyssey Charter School. The school *has* been audited annually, by a firm of Certified Public Accountants since its inception. Over the years, two qualified firms have been engaged to perform the audits. The last nine years' audit reports are available at http://odysseycharterschooldel.com/financial-reports-tax-returns/. They all have unmodified (clean) opinions and there have been no findings reported since 2013. That one 2013 finding was satisfactorily cleared.

The school's audits are performed in accordance with Generally Accepted Auditing Standards and under Government Auditing Standards. The auditor's report contains the following language: "As part of obtaining reasonable assurance about whether the School's financial statements are free from material misstatement, we performed tests of its compliance with certain provisions of laws, regulations, contracts, and grant agreements, noncompliance with which could have a direct and material effect on the determination of financial statement amounts. However, providing an opinion on compliance with those provisions was not an objective of our audit, and accordingly, we do not express such an opinion. The results of our tests disclosed no instances of noncompliance or other matters that are required to be reported under Government Auditing Standards." What this means is that, although the auditor is not required to give an opinion on compliance with laws and regulations, the auditor is required to test for non-compliance that would have a material effect on the financial statements and that no such noncompliance was detected during the audit. Had it been detected; it would have been required to be included in the report. Also, the school's previous reports indicate a similar, high level of financial accountability which should give you and the committee a high level of comfort.

I feel strongly that the current issues can be resolved cooperatively by the Department of Education, the Charter Schools Accountability Committee, the School and AHEPA, without change to the AHEPA's essential position on the School's Board. If I can provide you with any assistance, please do not hesitate to contact me.



I fully support AHEPA's current role with the Odyssey Charter School Board, here is why;

A little over ten years ago my wife, Anne, and I attended an open house at Odyssey Charter School. The school was small, but the passion, energy and vision that was displayed by the late Tony Skoutelas was inspiring. Tony, at the time was the Head of the School, one of the schools founding members and most notably an AHEPA member. Tony's passion for a school infused with Greek academics and culture was indicative of someone who was working for a cause in which they strongly believe.

I saw this passion again later while working as the architect to support Dimitri Dandolos and the Odyssey School Board as they moved the school out of that small building and into the Barley Mill Campus where the school resides today. That transformation was challenging to say the least, with one obstacle to overcome after another. However, the OCS School Board with its AHEPA majority and tremendous support from AHEPA volunteer members, never wavered from the mission. In fact, this group operated in a persistent, dedicated and professional manner throughout the entire process. Again, that passion that's evident when someone is working for something they believe in, was on display.

I witnessed firsthand how Dimitri Dandolos worked full-time and on a completely volunteer basis for almost four years on the Barley Mill OCS Campus project. During this time he performed multiple roles for the school, not the least of which was the de-facto Director of Major Capital Improvements. While this was not a paid role, he performed his duties most admirably. I've been practicing as a licensed architect for nearly 20 years, focusing almost exclusively on Delaware public K-12 projects. I've worked with countless full-time, highly paid individuals performing the same role which Dimitri performed on a volunteer basis. In my opinion, Dimitri's overall skill level and effectiveness is unsurpassed by any of those individuals. From my vantage point, whether working with professional consultants like myself, other School Board members, other AHEPA volunteers, school administrators, school staff or the greater community in general, Dimitri's efforts towards the Barley Mill project were focused and goal oriented but at the same time, respectful and enthusiastic. He, along with the support of other AHEPA volunteers, provided the vision of the OCS Barley Mill Campus project and pooled the significant resources that were necessary to make the vision a reality.

I've had the privilege of being involved in the OCS Barley Mill Campus project from its earliest planning stages all the way through to seeing "kids in seats". I participated in all of the following steps in some form or another; initial design and testing of the concept, due diligence exploration, property acquisition, the master planning phase, land use planning and regulatory approvals, educational programming, the fit out conversions of the buildings from a business occupancy to an educational occupancy, the systematic phasing and implementation of the master plan, demolition of select buildings to create playing fields and playgrounds, strategic expansions to promote a campus feel and provide greater accessibility. Throughout this lengthy and arduous process, an emphasis was placed on the goal of providing quality learning environments and an atmosphere conducive to student success, health and safety. This goal was no doubt achieved as evidenced by the beautiful campus Odyssey Charter School now enjoys. The campus will only improve as the master plan continues to be developed and implemented. While impressive, the fact that this vision became a reality is not really surprising, knowing the individuals that were behind making it happen. What is surprising and equally impressive is the Capital Improvements budget under which this campus was delivered. In the end, approximately 250,000 square feet of K-12 learning environment, across four buildings was renovated for approximately \$25 per square foot. This staggeringly low amount represents tens of millions of dollars of taxpayers money that was

saved throughout this process. This is the immensely positive impact that the AHEPA majority school board led by Dimitri Dandolos and other AHEPA volunteers had on the development of the OCS Barley Mill Campus project!

My understanding of the successes achieved throughout the Campus development project are further underscored by the Hellenic based education my own family received from Odyssey Charter School. Dear Charter School Accountability Committee Members,

I am writing to provide some additional information to CSAC and to rebut some of the statements and comments you have received during this Formal Review process for Odyssey Charter School.

I have assisted the Board of OCS for over 6 years and have direct, first hand, knowledge of the governance issues surrounding OCS. I put together the financing team that successfully issued \$34,600,000 of bond financing (closing February 2015) through which OCS purchased its Barley Mill Campus. Governance issues arose at that time and with the assistance of an independent professional organizational consultant were successfully resolved to everyone's satisfaction (including CSAC) at that time.

The most important issue before you is AHEPA's retention of its ability to appoint a majority of the board. There are 4 reasons, enumerated below, an AHEPA majority is necessary and essential to the continued success of Odyssey Charter School.

1. The bonds issued to finance the Barley Mill campus were public securities, issued by the State of Delaware through its Department of Economic Development were subject to federal and state securities laws requiring detailed disclosure on all aspects of OCS's operation including specifically its board composition. The governance of OCS was throughly reviewed by DEDO, their legal representatives, bond counsel, disclosure counsel, OCS counsel, trustee's counsel, investors counsel and by financial analysts of potential bond investors. **Prominent in the disclosure documents on OCS was the fact that AHEPA formed the school and in accordance with the bylaws was able to appoint a majority of board members and the President of the board.** Two issues of concern arose. The power of a board Executive Committee and the lack of turnover of board members both AHEPA appointed and parent and teacher members. The issue of an AHEPA majority was never raised by any of the above participants including CSAC during the major charter modification required for the Barley Mill purchase and school expansion to k-12.

I was directly involved in the rewriting of OCS's bylaws as required by investors through the bond documents. The Executive Committee was abolished and term limits were imposed requiring new appointments and elections for both AHEPA and non AHEPA members. After the new bylaws were put in place during the spring of 2015 a new nominating process was established and several new AHEPA members and all other positions were filled through a newly established nominating committee and process with new quality applicants.

2. You are told the AHEPA majority are bad stewards with many conflicts of interest. I am sure you are aware that these "bad stewards" have created and grown a charter school that ranks among the very best in Delaware and is in very high demand by parents. Despite allegations of financial impropriety, the schools audits are clean and free of any

operational comments. The CBOC for Odyssey has been meticulous in its oversight and reporting for several years now. The bond investors have held monthly conference calls with school leaders and scrutinize financial results, operations and capital budgets monthly. The analysts for the bond investors are among the very best in the country with very deep experience in charter issues. So they have also added a level of oversight that most are not aware of. In addition OCS has an outstanding dual language program utilizing the Greek language which is recognized by the Department and national and international universities. Your potential actions put all of this at risk.

During the bylaw revision process the independent consultant (Dick Haviland of Brandywine Organization Consultants - recommended by Paul Stock of DANA) prepared and conducted a survey that included all board and school leaders and 10% of all parents and teaching and other staff (drawn at random). To the question of how important is the continuing involvement of AHEPA, 70% replied it was vital or very essential. Another 23% said it was important but not essential. Only 7% considered it not important.

3. You have received comments that Odyssey can remain a Greek school and work with the Greek Ministry and universities with or without AHEPA. Unfortunately this is not the case. While perhaps theoretically true, almost all of the financial support OCS has received and many of its most creative programs are all in place specifically because of AHEPA's involvement and run through it and its membership. Take away the AHEPA majority and all of their initiatives will be compromised. It is little known but shortly after the bond financing was completed and the bylaws were revised, the then headmaster came forward, with the support of then board members Jen Ballas (who continues to negate Greek control to this day) and Kate Klemas, with a proposal to make Greek optional. This was defeated by the board, but with current school leadership in the hands of good, but non-Greek people, there will be no way to block future efforts of this kind. The fact that school administration is not lead by leaders fluent in Greek language, culture and hellenic education principles almost demands that the board remain actively involved in academic programming.

One of Odyssey's core missions is to "Enhance each student's understanding of Mathematics, English, Science, and other Western languages by utilizing the Modern Greek language, with a Mathematics focus as a vehicle to explore the roots of vocabulary, mathematical concepts, and scientific theories." You have heard from Marina Mattheoudakis that without AHEPA she would not be at OCS.

4. Ongoing fundraising will be severely compromised. You have heard about AHEPA fundraising commitments. The campus is not completed yet and major work and fundraising remains. Actions to diminish AHEPA's control will place these commitments and the Greek dual language program at risk.

In closing, Odyssey Charter School is truly unique in many ways. Because of these difference and unlike, say a Newark Charter School (another Delaware highly successful charter), Odyssey requires a strong level of operational engagement from its Board of Directors with an AHEPA majority. Without this level of engagement Odyssey will slowly but inexorably flounder and change its mission. I have observed firsthand the efforts of those who are putting personal grievances ahead of the welfare and educational opportunity of 1,900 students and their families.

Odyssey has grown into a \$27 million business in a very short time. It has had its hiccups and bumps, to be expected of any fast growing organization with a unique mission and vision. However I can personally attest, as I have been at the table for most of the past 6 years, that all of its decisions have been made with the objective of providing the best possible outcomes for its students. And, unlike its current critics, no decisions were made putting personal objectives ahead of the good of the school.
