AGREEMENT EXERCISING SECOND OPTION TO RENEW

(The Gale Group, Inc.)

- C. Pursuant to the Contract, the Board now desires to exercise its second option to renew the Agreement for a twelve (12) month term, and Gale accepts this second option to renew on the terms and conditions hereinafter set forth. One (1) option to renew remains under the Agreement.

NOW THEREFORE, in consideration of the mutual covenants and conditions contained herein, the parties agree as follows:

- Incorporation of Recitals: The matters recited above are hereby incorporated into and made a
 part of this Second Renewal Agreement.
- 2. **Definitions**: Any and all capitalized terms contained in this Second Renewal Agreement, and not defined herein, shall have the definition as set forth in the Agreement.
- Term: The parties agree to renew the Agreement for a period commencing July 1, 2010 and ending June 30, 2011 ("Second Renewal Period"), unless terminated sooner as provided in the Agreement.

- 4. Compensation: The total maximum compensation payable to Consultant during this Second Renewal Period shall not exceed the sum authorized by Board Report 10-0922-PR24, ("Total Maximum Compensation") as may be amended from time to time.
- Services: Gale shall continue to provide access to the Licensed Content and provide the Services as listed in the attached Schedule 3.
- Agreement: Except as expressly provided in this Second Renewal Agreement, all terms and conditions of the Agreement are and shall remain in full force and effect during the Second Renewal Period.
