AGREEMENT EXERCISING THE FIRST OPTION TO RENEW THE SERVICES AGREEMENT

(INTERNATIONAL BACCALAUREATE ORGANIZATION)

This agreement exercising the first option to renew ("First Renewal Agreement") is entered into by and between the Board of Education of the City of Chicago, a body politic and corporate (the "Board"), with offices located at 125 S. Clark St., Chicago, Illinois 60603, and International Baccalaureate Organization (the "Vendor" or "IB"), collectively (the "Parties").

RECITALS:

- A. The Parties entered into a Services Agreement (the "Agreement"), under Board Report 10-0428-PR23, for a term commencing on July 1, 2010 and terminating on June 30, 2012, with the Board having two (2) options to renew for periods of two (2) years each.
- B. Pursuant to the Agreement, the Board now desires to exercise its first option to renew and extend the Agreement for a period of two (2) years and Vendor accepts this option to renew and extend on the terms and conditions hereinafter set forth. There is one (1) option to renew remaining under the Agreement.

NOW THEREFORE, in consideration of the mutual covenants and conditions contained herein, the Parties agree as follows:

- Incorporation of Recitals: The matters recited above are hereby incorporated into and made a part of this First Renewal Agreement.
- 2. **Definitions**: All defined terms used herein shall have the same meaning as defined in the Agreement unless otherwise defined herein or unless the context requires a different meaning or connotation.
- 3. Renewal Term: The Parties agree to renew the Agreement for a period commencing on July 1, 2012 and ending June 30, 2014 ("First Renewal Term"), unless terminated sooner as provided in the Agreement.
- 4. Services: During this First Renewal Term, Vendor agrees to provide the services set forth in Exhibit A-1 ("Services") which is attached hereto and made a part here of, in accordance with the terms and conditions of the Agreement and this First Renewal Agreement. "Services" means, collectively, the services, deliverables, duties and responsibilities described in the scope of Services and any and all work necessary to complete them or carry them out fully and to the standard of performance required by this First Renewal Agreement. The Board retains final authority with respect to all Services related decisions. The Board may, from time to time, request changes in the Scope of Services. Any such changes shall be documented by a written amendment to this First Renewal Agreement signed by both parties and the Board's General Counsel.
- 5. Compensation: Subject to all of the terms and conditions of the Agreement and this First Renewal Agreement, compensation for the provision of services and deliverables during the First Renewal Term shall be at rates and pricing identified in the First Renewal Agreement and in Exhibit A-1, with the maximum total compensation payable to Vendor for the First Renewal Term not to exceed Two Million Three Hundred Fifty Seven Thousand Nine Hundred and 00/100 Dollars (\$2,357,900.00) ("Total Maximum Compensation").
- 6. Freedom of Information Act: Vendor acknowledges that this First Renewal Agreement and all documents submitted to the Board related to the First Renewal Agreement are a matter of public record and are subject to the Illinois Freedom of Information Act (5 ILCS 140/1) and any other comparable state and federal laws and that this First Renewal Agreement is subject to reporting requirements under 105 ILCS 5/10-20.44. Vendor further acknowledges that this First Renewal Agreement shall be posted on the Board's Internet website at www.cps.edu.
- 7. Original Agreement: Except as expressly provided in this First Renewal Agreement, all terms and conditions of the Agreement are and shall remain in full force and effect during the First Renewal Term.

Services as described herein shall be conducted pursuant to the terms and conditions of the a the Services Agreement (the "Agreement") and first renewal agreement ("First Renewal Agreement") between the Board of Education of the City of Chicago (the "Board") and the International Baccalaureate Organization ("IB" or "Vendor").

I. GENERAL DESCRIPTION OF SERVICES:

For the Term of the Agreement, IB shall provide to teachers and administrators from those Chicago Public Schools ("CPS") that the Office of Curriculum and Instruction has designated to participate in the International Baccalaureate Diploma Programme, Middle Years Programme and Primary Years Programme (collectively, the "Programmes"), as well as the IB Career-related Certificate, a series of teacher training workshops and seminars throughout the year covering the different subject groups that comprise the Programmes. IB staff shall provide the curriculum and materials (see Section II – "Deliverables") for these training workshops and seminars, and shall give the participating schools support in implementing the Programme curricula.

IB services shall also include (1) advising schools on how to prepare an application for IB authorization and evaluation visits; (2) provide student examinations, grading, and monitoring of assessments; and (3) provide Programme evaluation and feedback.

II. DELIVERABLES AND COMPENSATION:

IB shall be paid in accordance with the pricing listed below at a total cost not to exceed \$2,357,900. If a payment date is not identified below, IB shall be paid in accordance with the monthly invoices IB submits, in accordance with the pricing listed below.

IB provides workshops which are up to 2 1/2 days in length. The cost per teacher is approximately *\$700. Workshops are held off-site throughout the year as well as on-site in the fall and are categorized in the following three ways:

Category 1 Workshop

The overall purpose of workshops in this category is to provide professional development and assistance for schools that have decided to apply for IB authorization. They are equally relevant for educators who are new to a school with an existing IB programme and those interested in joining an IB school.

- Participants will gain an understanding of the basic philosophy and curricular model of the programme.
- Participants will gain an understanding of programme standards and practices.
- Participants will gain an understanding of the appropriate programme framework.
- Participants will gain an understanding of the application authorization and implementation processes.

Category 2 Workshop

The overall purpose of workshops in this category is to provide a forum for experienced IB educators, focusing on programme delivery. There is an emphasis on assessment, teaching and learning methodologies, and exploring best practice in the classroom.

- Participants will make connections between the programme framework and practice.
- Participants will enhance their understanding of the role of assessment in IB programmes.
- Participants will discuss and analyze standards and practices appropriate to their role.
- Participants will engage in discussion and activities aimed at sharing pedagogical techniques.

Category 3 Workshop

The overall purpose of workshops in this category is to provide a forum for experienced educators to build on and enhance their professional development portfolios. Participants will engage in-depth investigation into specific areas of interest and expertise.

- · Participants will engage in detailed discussion around topics such as:
 - Learning theory
 - Pedagogy
 - Assessment
 - Other scholarly interests
- Participants will engage in detailed discussion around topics such as:
 - Subject specific seminars (i.e. changes to the IB curriculum)
 - Subject specific content
 - Administrative leadership
 - Pedagogical leadership

*Workshop fees typically increase annually by 10%
