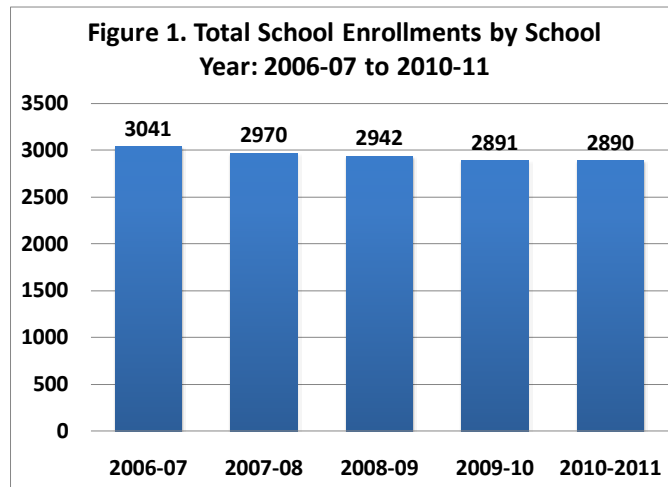

EXECUTIVE SUMMARY

This executive summary identifies some of the changes, trends or patterns over the past five years. The 2010-2011 total enrollment (Part 1A) of 2890 is essentially the same as last year's enrollment (2891). Projected enrollment for 2010-11 was 2893. Figure 1 below shows the enrollment changes over the past five years.



The federal government issued new guidelines/categories for collecting and reporting race data. The tables in this report are reformatted to present enrollments by the new racial categories. These new guidelines had an impact on the enrollments of some of the racial groups. Therefore, the tables should be interpreted with caution. Due to state reporting requirements, enrollment numbers do not include off-campus special education placements or Safe School student enrollments.

Trends and Patterns

- The grade 9 total enrollment is down somewhat from 2009-10, reflecting a drop of 43 students (Part 1A).
- Black enrollment has declined gradually over the past five years, with a decline from last year, down 2.6% to 31.7%.
- White enrollment also declined over the last five years and now stands at 43.1%, a drop of 2.7% since last year.
- Hispanic and multiracial enrollments continue to increase.
- Special Education students in the Off Campus Placement Program (Part 1D) decreased to a total of 123, after several years of increases.
- The number of District 202 residents attending non-public schools (Part 1E) increased to 299 from the 263 reported in 2009. Most of this increase is attributed to higher enrollments of students attending Loyola Academy, North Shore Country Day School, and Ida Crown School.
- Several departments showed a slight decrease in enrollees (Part 2A) with the exception of Math, Science, History/Social Science, and World Languages which all showed increases for the second year in a row.

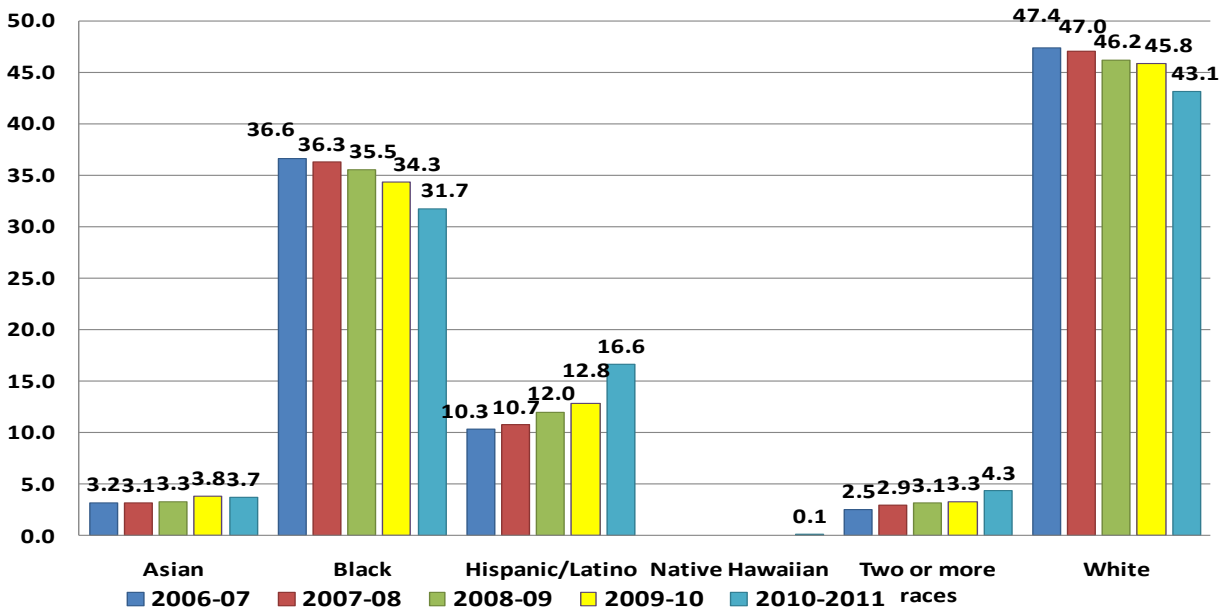
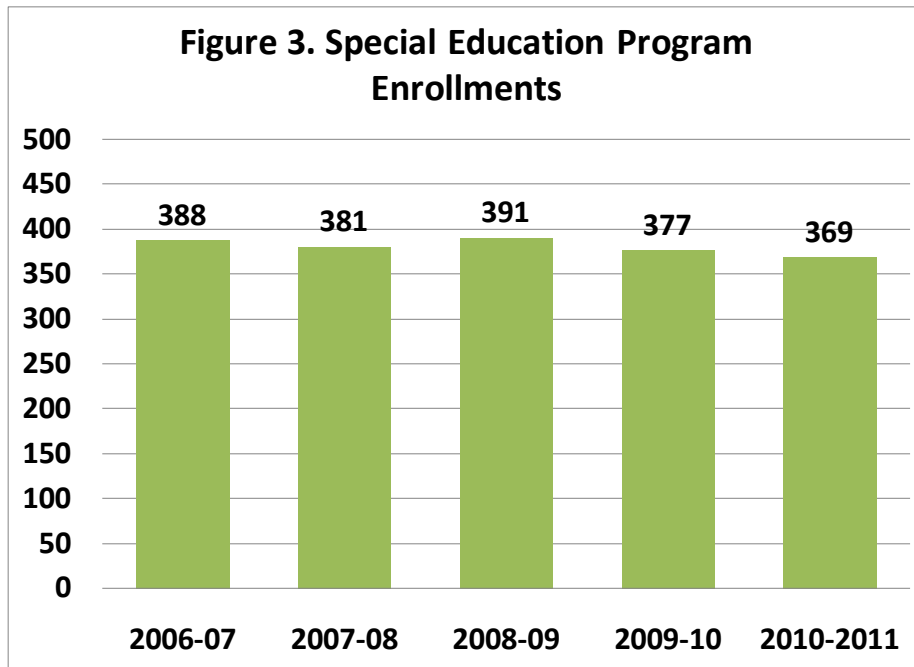


Figure 3. Special Education Program Enrollments

Figures 2 and 3 provide graphs of enrollments by race as well as special education enrollments over the last five years.

Figure 2. Enrollments by Race
