I. Call to Order

V. New Business

a. Book Study: "The Whole Brained Child"

A general discussion was had on chapter 3.

Read chapter 4 and be ready for discussion at the next meeting.

b. Curriculum Connections: Division the Common Core Way – Mrs. Shreves

Mrs. Shreves was not in attendance but a video was shown of her students explaining the Common Core way of doing multiplication and division.

c. School Recognition Funds (SRF) Ballot

Kristin Fanning stated that she made an error and that according to the bylaws teachers and staff needed to have the opportunity to suggest changes to the ballot. She received three suggestion:

1. Include paras with teachers in the dividing the money as 80% to teachers and 20% to remaining staff.
2. Take off the option to give SAC money since they already get money from the state.
3. Put a caveat that only staff members that are at WCE for 6 months or longer would be included in the money division.

Mrs. Mitidieri stated that she didn't think that a person's monetary value should attached to a person's worth.

A discussion ensued about what the rules were for money distribution. Bethany stated that she and Kristin contacted the District person about it and the only rule was that there had to be a 51% agreement on how to money should be used, and that SAC ratifies it. Kristin added that there could be four options.

After much discussion, none of the suggestions were approved by a show of hands taken on each suggestion. It was also added that everyone would get a full vote. It was also added that "itinerants" would be used to clarify the distribution for those people who service more than one school, and to add "itinerants" to the bottom of the ballot. By a show of hands the ballot with everyone getting a full vote and the addition of the term "itinerants" was approved.

Kristin said she would make the changes and send the ballot out to the staff. They would then vote next Friday. Then SAC can approve the results of the vote.

d. SAC Survey

Kristen reported the District requires that 80% are completed.

e. FSA Reading/Math 3rd – 5th

The FSA testing is going well. Third grade reading was this week and their math FSA will be next week. Fifth graders will have their reading next week as well.
