# **Program Challenge Gifted Enrichment Center**

The goal of the Griffin-Spalding County School System is to provide quality services that efficiently and effectively meet the needs of all students. Begun in 1999, the Program Challenge Gifted Enrichment Center is designed to meet the needs of elementary school students who have been identified for gifted services. The Center, located at 205 Spalding Drive, serves students in grades K-5 one day each week. Students are grouped by grade level with other students from across the county. While at the Program Challenge Center, teachers work with the students on standards-based learning, problem solving and research skills while fostering emotional growth, creativity, leadership and independence. The motto of the gifted program, "Spark the Future, Challenge the Mind," forms the central basis of all instruction and activities at the Program Challenge Gifted Enrichment Center.



# **Georgia Definition of the Gifted**

A student who demonstrates a high degree of intellectual and/or creative ability, exhibits an exceptionally high degree of motivation, and/or excels in specific academic fields, and who needs special instruction and/or special ancillary services to achieve at levels commensurate with his or her abilities. (For eligibility requirements, please refer to your child's placement information.)

## **Our Mission Statement:**

Our mission is to empower, enrich, motivate, and inspire students to expand their creativity, critical thinking and problem-solving skills to reach their highest potential.

## **Our Vision Statement:**

Our vision is to enable students to be supportive of others, empowered to learn and step out of their comfort zones to persevere through the real world.

# **Our Purpose and Core Values**

The purpose of gifted education is to serve students identified with the State of Georgia's gifted criteria by providing stimulating and challenging opportunities that will foster creativity, leadership and independence.

We believe that:

- Every student has a right to develop to his/her greatest ability.
- All students shall be recognized as diverse individuals rather than a single homogeneous group.
- Students benefit from interaction with other students of similar abilities and talents.
- Access to a differentiated curriculum enables students to broaden their base of interest through advanced research skills and methods, creative thinking, and problem solving.

- A nurturing environment, which supports student social and emotional growth as well as individual needs, must be sustained.
- Effective staff, student, and parent communication must be maintained.
- Student achievement should be evaluated using appropriate and specific criteria and should include teacher, self, and collaborative evaluation.
- Staff professional learning fosters increased knowledge of the needs of gifted students and supports the development of appropriate opportunities for learners of all ages.

#### **Curriculum Statement**

The instructional curriculum activities at the Program Challenge Center are based on Georgia Standards of Excellence, SMPs, Science and Engineering practices, using the enrichment model. Each course of study offered emphasizes the state standards, research skills, opportunities in problem solving, plus development of creativity, leadership and independence.

All of these together lead to emotional and intellectual growth. Our curricular program integrates engineering with elementary science topics while making connections with literacy, social studies, and mathematics.

# **Program Challenge Progress Reports**

The performance of each student attending classes at Program Challenge will be evaluated frequently. Reports containing information concerning the students' evaluations will be sent home during the school year. These reports will have a score from 1-4 depending upon the performance of the student.

# **Makeup Work Guidelines**

#### **Administrative Procedures for Gifted Education**

The following is a guideline for students who attend Program Challenge:

Students going to Program Challenge will be exempt from work done in their regular classroom on the day they are in Program Challenge.

Students are not exempted from any tests or projects required by teachers at the regular school.

# **Continuation Policy**

Student performance in the gifted program will be evaluated annually and the conclusion of each grading period by the local school's gifted education program teacher(s). This evaluation will be based on the student's performance in the gifted program classroom. Parents will be notified as to whether performance is satisfactory (80% 3s and 4s or B Average) or unsatisfactory.

In the event a student's performance is deemed unsatisfactory in gifted education class (es), parent(s) will be notified and a meeting will be scheduled to develop an intervention plan. The parent(s), principal's designee, and the gifted education teacher(s) in the area or areas in which the student is experiencing difficulty will comprise the intervention team. The student will be included when appropriate. In the event that the parent is unable to attend this meeting, the parent will be sent a written notification of the intervention plan. The intervention plan will be implemented during the probationary period which lasts for one semester.

Upon completion of the intervention/probationary period (one grading period), a second meeting will be scheduled to review the student's progress. At that meeting the intervention team (including the parent(s) and the student) will meet to evaluate the student's performance. The student's academic record will be reviewed to determine if satisfactory performance has been maintained during the semester of probation. The team will determine continuation in or dismissal from the gifted program. The gifted program teacher and principal's designee will

make the final decision regarding continuation with input from the parent(s) and student. Parents who do not attend this meeting will be notified of the intervention team's recommendation for their child's continuation or discontinuation in the gifted program.

Parent/Guardian who decide to remove a student from the gifted program must make their request in writing to the gifted program teacher. The request must state the reason(s) for the request. This request for dismissal will be acknowledged by the gifted program teacher. A conference will be scheduled to discuss the student's placement. If parent(s)/guardian(s) have chosen to remove a student from the program and request reentry later, the guidelines for reentry will be the same as for a student who is not recommended for continuation (students must re-qualify). Students who have been dismissed, (or withdrawn due to parent/guardian/student request) can be referred for re-entry after two semesters. They must be able to demonstrate satisfactory academic achievement in all subject areas and meet eligibility criteria in place at the time of re-entry.

# **Field Trips**

Field trips are an integral part of the instruction at the Program Challenge Center and will be scheduled to supplement the curriculum. These trips are designed to enhance the student's overall learning experience and expand their thinking. Safety while learning is of the utmost importance to the Enrichment Center; and for this reason, we feel it is necessary to implement certain policies concerning upcoming field trips.

#### Expectations are that students:

- \* must exhibit expected appropriate behavior.
- \* must be in good standing with bus conduct.
- \* must maintain proper respect with authority figures.

# Chaperones will be selected based on a need for adult to student ratio.

- 1. Chaperones must be on the GSCS approved list of volunteers.
- 2. Chaperones must be willing to supervise small groups of students and follow chaperone guidelines.
- 3. Approved chaperones are the only persons allowed to attend Enrichment Center field trips.
- 4. Chaperones MUST ride the bus to and from the destination.
- 5. All chaperones must be 23 years old to attend GSCS field trips.



# **Field Trip Deadlines**

## Deadlines are of the utmost importance.

Reservations must be made and buses must be requested. <u>Deadlines not met will result in your child NOT attending field trips.</u>

Chaperones wishing to attend field trips must also meet all deadlines and financial obligations to be considered for field trip attendance.

The Enrichment Center will not deny a child a field trip because of lack of funds; however, if sufficient funds are not collected to cover the cost of the trip, it may be cancelled.

We do offer a way for students with financial need to get help. <u>Applications</u>, <u>letters of need from parent/guardian</u>, and essays must be submitted in a timely <u>manner in order to be considered</u>. This is done on a case by case basis.

\*\*There will be no refunds on trips <u>after</u> the money has been sent to the field trip destination.

\*\*Last dates for refunds/partial refunds will be clearly typed on each permission/informational letter for each field trip.

#### **Attendance**

Students identified as gifted and whose participation has received parental consent shall receive at least five segments per week (or the yearly equivalent) of gifted services, using one of the approved gifted service models described in the Georgia Department of Education Resource Manual (Appendix A) for Gifted Education Services.

<u>Student Attendance to Program Challenge is REQUIRED unless the student has an excused absence.</u> Our curriculum moves quickly and is designed for gifted students. Challenging material will become overwhelming if students are absent frequently.

#### Lunch

Lunch is served daily at Program Challenge. The meals are prepared by the Griffin-Spalding County Nutrition Department and are delivered to the P.C. Center. Lunches must be paid through student's home school account. You may join us for lunch at 11:30. If you wish to order a school lunch, please call the office before 9 A.M. to place your order. Students may also bring lunches from home.

# **Important Papers**

It is important that the P.C. Center has up-to-date information on your child! The green information sheet is of vital importance. This information allows the staff to get in touch with you in case of an emergency, alerts the staff of allergies or medical problems, and states who MAY or MAY NOT pick up your child from the Center. (Those picking up the students will be asked for identification and names will be verified from the list on YOUR CHILD's GREEN SHEET). If a name cannot be verified and we cannot get in touch with the parent/guardian to get permission for the child to leave with that person, the child will not be released to that individual. Please make sure there is an up-to-date sheet on file in the office. This form is updated annually!
