## What does it mean to be a Title I School?



- Being a Title I school means receiving federal funding (Title I dollars) to <u>supplement</u> the school's existing programs. These dollars are used for...
  - Identifying students experiencing academic difficulties and providing timely assistance to help these student's meet the State's challenging content standards.
  - Purchasing supplemental staff/programs/materials/supplies
  - Conducting PAFE meetings/trainings/activities
  - Recruiting/Hiring/Retaining Highly Qualified Teachers
- Being a Title I school also means, parents have a right by law to be involved in decisions made at the school.

## What is the 1% set-aside and how are parents involved?



- Any LEA (Local Education Agency) with a Title I Allocation exceeding \$500,000 is required by law to set aside 1% of it's Title I allocation for parental involvement.
- Of that 1%, 10% may be reserved at the LEA for system-wide initiatives related to parental involvement. The remaining 90% must be allocated to all Title I schools in the LEA. Therefore each Title I school receives its portion of the 90% to implement school-level parental involvement.
- You, as Title I parents, have the right to be involved in how this money is spent.

### What is the School-Parent Compact?



- The compact is a commitment from the school, the parent, and the student to share in the responsibility for improved academic achievement

# How will I be notified if my child is taught by a teacher who is not Highly Qualified?



- The Every Student Succeeds Act of 2015 (ESSA) requires schools to notify parents if either of the following circumstances occur in your child's classroom:
  - Your child has been assigned to a teacher who does not meet the requirements of a highly qualified teacher, or
  - Your child has been taught for four consecutive weeks or more by a teacher who does not meet the highly qualified requirements.

Our Principal will mail a letter home to the parents of students that are assigned to a non Highly Qualified teacher for more than 30 days.

# How is the evaluation of the District and School's Parent & Family Engagement Plan Conducted?

#### **CCRPI**



Beginning with the 2012-2013 school year, the GaDOE transitioned from needs improvement (NI) school designations based on adequate yearly progress (AYP) reports to Reward, Priority, Focus and Alert Schools designations based on ESSA Flexibility Waiver formulas. Title I schools have implemented specific programs and interventions based on Reward, Priority, Focus, and Alert Schools status. In addition, the GaDOE ESSA Flexibility Waiver outlines Georgia's new Single Statewide Accountability System, the College and Career Readiness Performance Index (CCRPI). The CCRPI will serve as a comprehensive report card for all schools in Georgia. The state system will give parents, students, teachers and families a more complete and comprehensive picture of where a school or district is meeting performance expectations and where it is not.

### **CCPRI & Designated Status**



- For the 2019-2020 school year, Charles Drew High has been designated as a Priority School under Georgia's ESEA Flexibility Waiver. This is based on our school's performance over three consecutive years, and we keep this designation until our school meets the exit criteria for Priority School status.
- Our current CCRPI score is 59.9.
- As a priority school, we will work together with parents, community and our District to develop a school plan that delivers necessary support to address the learning needs of our students and increase their academic success.

### Complaint Procedures



- Procedures for filing a complaint are located on last page of the CCPS Student Handbook.
- Grievant submits written complaint to Coordinator/Compliance Officer.
- Coordinator/Compliance Officer notifies respondent within 10 days asking for more information.
- Respondent submits answer within 10 days to Coordinator/Compliance Officer.
- Within 10 days of receiving respondent's answer the Coordinator/Compliance Officer schedules a hearing with the grievant, the respondent, and the principal or other designee.
