Background Information:

The District operates extended day programs at multiple schools. Each of these programs offer a variety of enrichment activities for enrolled students. Principals may offer other after school enrichment activities based upon needs and requests. The RFP establishes minimum requirements for vendors to be considered and added to an approved vendor list for these programs. Vendors are required to return a percentage of their revenue to the school.

Educational Impact:

Encourages students and parents to take advantage of additional learning and growth opportunities which are conducive to the educational process.

Strategic Plan Impact:

Supports the District's Mission Statement by providing additional learning opportunities for students to help them master all academic standards.

Fiscal Impact:

Fees paid to the school by the vendor provide additional revenue for the purchase of goods and services.
