**2022 - 2023 DRESS CODE Guardian LETTER**

Students' dress should be appropriate for school and not disruptive to the learning environment. The name of any student deemed to be inappropriately dressed will be sent to the House Principal and Guidance Counselor. They will determine the appropriate course of action based on the guidelines below.

School attire should be neat and clean, modest, serviceable and appropriate for the student's age and/or weather conditions. Madison County Board of Education Policy states that building level administrators have the authority to determine inappropriate dress.

**Dress Code Violation**

Any dress code violations will be listed here.

Violation of school dress code that includes standards for appropriate school attire					
Level 1	Non-invasive and non-suggestive clothing, jewelry, book bags or other articles of personal appearance. Pursuant to local dress codes, dress code violations for Level 1 may include but are not limited to bare feet; trousers, slacks, shorts worn below waist level; excessively short shorts or skirts; pants with holes above the knees; shorts length above fingers when arms extended at sides. sunglasses worn inside the building; hats, caps, hoodies, sweatbands, do-rags and bandanas or other headwear worn inside school building; novelty headbands(i.e. cat ears, unicorns, etc.); animal ears or any other type of ear; Face Paint (unless it is related to approved school activities or events ); animal collars.

Level 2	Invasive or suggestive clothing, jewelry, book bags or other articles of personal appearance. Pursuant to local dress codes, dress code violations for Level 2 may include but are not limited to depiction of profanity, vulgarity, obscenity or violence; promote the use or abuse of tobacco, alcohol or drugs; creates a threat to the health and safety of other students; creates a significant risk of disruption to the school environment; clothing worn in such a manner so as to reveal underwear, cleavage or bare skin; spaghetti straps, strapless tops, halter tops, see-through or mesh garments or other clothing that is physically revealing, provocative or contains sexually suggestive comments.
