Student Parking & Traffic Code

Section I. Introduction

Pearl City High School's Parking and Traffic Code is an extension of the Traffic Code of the City and County of Honolulu and Traffic Laws of the Hawaii Revised Statutes. Parking on Campus is a **PRIVILEGE** and NOT A RIGHT.

Section II. Parking Decals

- A. Parking decals are available for purchase by students. All vehicles parked on campus must have a valid parking decal, which shall be **DISPLAYED** either on the **INSIDE BY THE DRIVERS SIDE WINDSHIELD OR HANGING FROM THE REAR VIEW MIRROR**. Decal information must be clearly visible from the outside of the front windshield.
- B. In order to obtain a parking decal, **the following must be presented:**
1. "Student Parking Request" form is completely filled out with the appropriate signatures (parent or guardian and student)
 2. Current Hawaii State Driver's License
 3. Current Vehicle Registration
 4. Current No Fault Insurance Card
 5. Current Vehicle Safety Check
 6. Valid Student ID
 7. Proof of GPA of 2.5 or higher
 8. **Cash Only / Exact Change** (prices dependent on which "Tier Parking Row", decal you purchase)
 - a. 1st Tier Parking Row – **OFF LIMITS**, (this parking Tier is for Faculty & Staff only. **NO STUDENT'S ALLOWED TO PARK ON THIS TIER**)
 - b. 2nd & 3rd Tier Parking Row's (2 & 3) is \$35.00 per vehicle (**Blue Tier**)
 - c. 4th Tier Parking Row is \$30.00 per vehicle (**Orange Tier**)
 - d. 5th Tier Parking Row (bottom/last row) is \$25.00 per vehicle (**Green Tier**)
 - e. Parking Permits are valid for the entire "School Year" marked on the Parking Permit
- C. Should the parking decal be lost or stolen, etc....., all of the above in Section II B must be resubmitted and the appropriate fee will be assessed.
- D. Parking decals are **NON-TRANSFERABLE**. (One Student – One Decal – One Vehicle Only) Notify Security Manager if this vehicle is sold. A separate registration must be completed for each different vehicle.
- E. Improper or fraudulent application, use duplication etc....., of the parking decal will result in disciplinary actions, and/or forfeiture of parking decal, and/or denial for a decal application for the current school year.
- F. Students that are frequently tardy to school may have their parking privileges revoked.

Section III. Parking Regulations

- A. All student vehicles parked on campus during school hours, **MUST CLEARLY DISPLAY** a current and valid parking decal.
- B. Student parking is restricted to the “C” parking lot only, which is opposite of the gym.
- C. **No Loitering in parking lots.** **ALL** parking lots are off limits during school hours.
- D. All vehicles shall be parked within a marked stall. There is no parking anytime fronting a red painted curb or where posted signs prohibit parking.
- E. Only original issued parking decals are valid. Tampered with and all other decals including copies, duplicates, etc... are invalid and will be seized.
- F. All vehicles in violation of parking regulations are subject to being towed away at the owner's expense.
- G. At the discretion of the Administration, an issued parking decal may be seized and/or revoked at any time.

Section IV. Traffic Regulations

- A. Students driving on campus shall follow designated traffic patterns and comply with instructions by the Schools Security Attendants and Administration.
- B. All vehicles must be driven in a safe and careful manner, must follow all traffic codes and laws of the City & County of Honolulu, and the Hawaii Revised Statutes.
- C. Any vehicle being operated in a reckless and/or negligent manner may be reported to HPD.
- D. Some examples of violations that will result in forfeiture of the parking decal include but are not limited to: Speeding, being insubordinate, playing music loud, burning out, hopping curbs, etc.
- E. Any violation of these traffic regulations will result in disciplinary actions.

Section V. Traffic Pattern

- A. Morning (7:00am – 8:00am) and afternoon (1:00pm – 3:00pm) traffic will be One Way entering the campus from the main driveway (Ho'okie'kie Street) and exiting through the Waimano Home Road gate or the Momilani (back) gate.
- B. All student vehicles must exit through the Momilani (back gate) from the “C” parking lot.
- C. Two-way traffic is allowed during all other times unless otherwise designated.

Section VI. Tow Away Zones and Signs

- A. Any vehicle parked in areas which are clearly marked by signs “Prohibiting Parking”, will be subject to tow, at the owner's expense. There will be no exceptions.

Section VII. Closed Campus

- A. Entry and Exit into Campus by attending students will only be allowed before and after school. A security check post will be manned during school hours and only those with a Valid Off Campus Pass from the front office (Administration) will be allowed to exit, once school is in session.
- B. No loud music from vehicles, no carrying of passengers in the bed of truck (unless 18 years of age or older)
