

## Exploring Two-Dimensional Art (#0101005)

### Overview

Welcome to Exploring Two-Dimensional Art. This course is designed for 7<sup>th</sup> and 8<sup>th</sup> grade students who express an interest in fine arts. Students will investigate a wide range of media and techniques, from both an historical and contemporary perspective, as they engage in the art-making processes of two-dimensional works, which include drawing skills, painting, printmaking, and collage. Students will reflect on their own artwork and that of others through critical analysis to achieve goals related to craftsmanship, technique, and application of 21<sup>st</sup>-century skills.

### Discipline

Students are solely responsible for their own behavior. Class sizes are large, and student's success depends on how they act with their fellow students and instructor. In order to make this an enjoyable learning experience for all, students need to adhere to the school rules while working in the art room. If students choose not to obey the school rules, they will not be allowed to do the project, but will instead be assigned to an alternative learning situation.

### Evaluation

Art is not a pass/fail class. Assignments will be given with vocabulary, a rubric and a time schedule to complete their artwork. Assignments and grades will be posted on *My Student*. A= 100-90, B = 89-80, C= 79-70, D= 69-60, F= 59 & Below. Project grades are based on following a rubric, Elements of Art & Principles of Design, creativity, originality, work ethic, craftsmanship, and skill.

**25%** Studio Habits: Getting to class on time, coming prepared for class *like a pencil*, self-directed, working ethic, staying on task, completing assigned work during class, cleaning up materials, and using tools in a responsible manner: Students will earn 5 points daily.

*Please Note:* Students are not to text, play video games, watch videos, during class, failure to follow this policy will result in -10 points off studio habits for the week. **Any student found misusing the supplies/equipment or throwing objects will possibly receive a referral and will be removed from the art room by the instructor's discretion.**

### Attendance
