- Commits any act that is deemed egregious by the administration will not be allowed to attend the Braves/Kennesaw Mountain Day Trip on April 13, 2022.

If a student has made payments toward the trip and then loses the privilege of traveling on these trips because of inappropriate behavior, no refunds can be made by NFMS or *Jim Mulvihill Tours*. Any student who loses his/her privilege to attend the trip may appeal the decision through an appeal process. All students are expected to adhere to the FCS Code of Conduct and all policies and procedures as stated in the NFMS Student/Parent Handbook.
