





Unit 6

Why This Form of Government? How Did We Get Here?

Unit Focus

In this unit, students will obtain an understanding of decisions made at the Constitutional Convention, the historical basis for our government, and the fundamental principles found in the Constitution, checks and balances and separation of powers, as well as a framework for comparing our government with other styles of government; the need for a constitution, the case of Marbury v. Madison, and historical documents that influenced the writers of the Constitution and Declaration of Independence.

Concepts Explored

- In a democracy, rule of law influences the behavior of citizens, establishes procedures for making policies, and limits the power of government.
- How rule of law manifest itself in the Constitution.
- How effective is the Constitution at distributing power in terms of checks and balances and separation of powers
- Comparison of the American distribution of power with other forms of government around the world.
- Conflict of ideals with regards to the ratification of the Constitution.
