# **What Does Dual Enrollment (DE) Mean?**

Dual Enrollment (DE) is when a student attends the college of their choice (school that they met requirements for) and earns high school credits simultaneously with college credits.

- All schools that we partner with are a part of the University System of Georgia.
- All schools have discretion with regards to credit acceptance.
- If interested with out-of-state schools after graduation <u>CHECK</u> <u>BEFOREHAND</u> to decide whether DE is the best option for your student.
- Start with the end in mind! <u>Dual Enrollment is not a fit for every student.</u>

# **General Eligibility Requirements**

#### 1604.2. Grade Level Eligibility.

- 1. A student must be a 10th, 11th or 12th grade student at an Eligible High School, subject to the limitations set forth in these program regulations.
- a. Students in the 11th or 12th grade may enroll in any approved Dual Enrollment courses at an eligible participating postsecondary institution (USG, TCSG or private).
- b. Students in the 10th grade with a minimum SAT score of 1200 or minimum ACT composite score of 26 in a single national test administration, taken prior to the term of enrollment and in the GSFC Dual Enrollment system, may enroll in any approved Dual Enrollment courses at a TCSG, USG or private eligible participating postsecondary institution.

### State of GA Dual Enrollment:

- **Students grades 11<sup>th</sup> and 12<sup>th</sup> can participate in the Georgia Dual Enrollment program (10<sup>th</sup> graders can participate with specific requirements).**
- \* Students can take 30 credit hours of coursework for free (to be covered by State of Georgia). That is approximately 9 courses plus 1 lab. After that, if students would like to continue, they must pay for tuition, fees, and books out of pocket.
- \* This applies to both Technical System of Georgia students and University System of Georgia students

## Rising 10th Grade Requirements

#### Rising 10th Graders:

- 1200 versus 1050 SAT (minimums 480 Reading; 440 Math)
- o 26 versus 20 ACT (minimums 17 English/Reading & Math)
- Also upcoming 10th graders, please keep in mind that if you are taking advantage of the free option, you only have a total of 10 (30 hours) classes that you can take; full-time DE is at least 4 classes a semester (total of 8 classes per year)
- For rising 10th Graders: June 8, 2023
- ASU & Truett McConnell: Classes taken would be online- due to location-NO full-time option

# Clayton State University & Albany State University DE Requirements:

#### Rising 11th and 12th Graders:

- 3.0 Core GPA (meaning all non-academic electives have been removed)
- <u>1050 SAT or 20 ACT</u>
- Acceptance Deadline for Fall (August 2023): May 12, 2023 (Please do NOT go by CSUs or ASUs deadlines because they are NOT our/ESA deadlines)
- Request transcripts through GA Futures (FREE)
- ASU: Classes taken would be online- due to location- NO full-time option
- If you do not have very close to a 3.0 Core, we recommend applying to several schools to increase the chances of acceptance.

### Truett-McConnell College DE Requirements:

- 3.0 Overall GPA (Weighted)
- No SAT or ACT or Accuplacer Scores Required (unless you want to take a Math class)- (except RISING 10th gradersmust meet the previously stated requirements)
- Totally Online- we did not allow students to go full-time
- Private Christian College- Some public colleges and universities may not accept certain credit

# Truett-McConnell University DE Requirements, Continued:

- Acceptance Deadline for Fall Semester (August 2023):
   May 12, 2023 (Please do not go by TMU's deadline- WE at ESA have deadlines in place for various reasons)
- Request transcripts through GA Futures (FREE)
- If you do not have an overall 3.0, we recommend to apply to various schools

# Southern Crescent Technical, Atlanta Technical College, & Georgia Military College DE Requirements


- 2.6 (HOPE GPA)
- SAT: Reading: 25; Math: 24
- ACT: 17 Reading, 16 English, 19 Math
- Accuplacer: Reading: 64-120, Sentence Skills: 70-120, Elementary Algebra: 57-120

- Deadline for Fall Semester (August 2023): May 12, 2023 (Please do not go by SCTech's, ATech's, or GMC deadline- WE at ESA have deadlines in place for various reasons)
- 10th Graders are under the same requirements as previous schools

## Steps to Apply For Dual Enrollment

- 1) Register for the <u>SAT/ACT/Accuplacer</u> (if applicable for desired institution)
  - Ensure scores are sent to desired dual enrollment institution when registering. Score requested after registration may not be free.
- 2) Create www.GAfutures.org account
  - Ensure to answered all required questions, including SSN number
  - Use a personal email address when creating an account, not your CCPS
- 3) Visit desired dual enrollment school website (see slide 16)
- 4) Read dual enrollment institutional requirements on website
- 5) Apply to desired institution (ensure you apply using the DUAL ENROLLMENT APPLICATION; FREE!!!)
- 6) Request high school transcript (Through GA Futures) or provide HS counselor with institution email address to send transcript to.

# **Steps To Apply To Dual Enrollment**

- 7. Monitor application status once application is completed in its entirety (Questions regarding your application contact college DE advisor)
- 8. GET ACCEPTED!!!
- 9. Inform Mrs. Washington and Mrs. Garcia of acceptance by forwarding acceptance email to us via email!!!
  - Ensure you forward your acceptance email to both counselors.
  - Mrs. Garcia/Mrs. Washington will provide you with a time for accepted student orientation (virtual).
