- I. **Chairman Hulse called the meeting to order at 7:02PM.**
 - a. Chairman Hulse, Vice-Chairman McClure, Trustee Liss, Superintendent Jacobson and Clerk Heileson all present.
- II. **Chairman Hulse led the Pledge of Allegiance**
- III. **CONSENT AGENDA - ACTION ITEMS:** Trustee Liss Motioned to approve the Consent Agenda. Vice-Chairman McClure Seconded. 3 in favor. 0 opposed.

- IV. **INFORMATION ITEMS/REPORTS**
 - a. Superintendent Report: Water fountains will be delivered this week.
 - i. Election Day went well. We had a great turnout.
 - ii. Veterans Day: The 7th and 8th graders prepared a slideshow of students with pictures of veterans in their families. Once the slideshow was finished, we emailed it out and encouraged families to pass it on.
 - iii. Quarter 1 K-8 Attendance 92.7%, 9 K-8 and 4 PK Students 100%/ YTD 92.7%
 1. 2019-20 - Quarter 1 K-8 Attendance 97.0%, 22 K-8 and 4 PK Students 100%
 - iv. Fall IRI Scores (K-3 Students): The below percentages are right inline with the statewide average.
 - a. 51.7% Tier 1 (at grade level)
 - b. 20.7% Tier 2 (near grade level)
 - c. 27.6% Tier 3 (below grade level)
 - v. CHC Foundation Grant - \$5,000 for playground. We just finished phase 1 of the playground and we are hoping to start phase 2 in the summer of 2021.
 - b. Re-Opening Plans for 2020-21 School Year revisions.
 - i. Daily Procedures at School: Discussion was held.
 - ii. December School Schedule: The board discussed the school schedule for December. Superintendent Jacobson suggested we continue in December as we have been throughout the fall with Wednesday being our virtual day.
 - c. Plant Levy Discussion: A lengthy discussion was held regarding the needs of the Swan Valley School Facility. The board discussed having a town hall meeting to meet with the community to discuss the needs of the facility and the amount they would like to ask for at the next election.
