## School Board Meeting Minutes



- I. Chairman Hulse called the meeting to order at 7:02PM.**
  - a. Chairman Hulse, Vice-Chairman McClure, Trustee Liss, Superintendent Jacobson and Clerk Heilesen all present.
- II. Superintendent Jacobson led the Pledge of Allegiance.**
- III. INFORMATION ITEMS/REPORTS**
  - a. 2020-21 Swan Valley School District Re-Opening Plan: Eastern Idaho Public Health has moved Bonneville County into the critical phase since our last board meeting. A discussion was held with the board regarding the reopening plan for the school district.
    - i. Plan revisions (if needed)
  - b. COVID-19 (Coronavirus): Superintendent Jacobson made the recommendation to the board that the school stays in virtual learning mode until next wednesday, December 9th, and to hold our board meeting on Dcember 8th. This recommendation will give staff and students a little more rest time and the board can discuss the remainder of December school at the board meeting on the 8th.
    - i. School Closure (Virtual Learning November 30-December 4, 2020): A majority of our staff is home sick with COVID or have been in close contact with a positive case.
    - ii. Distribution of iPads: The iPads were distributed on Sunday evening with only a couple that needed to be distributed on Monday. All students have iPads at this time. This will help with virtual learning this week. The only students that do not have iPads this week are the Preschool students.
    - iii. Virtual Learning: The only materials we sent home this week were the iPads. The iPads have an app on them for reading and math assignments.
    - iv. Staff Work expectations: All staff is working from home this week to the best of their abilities. We have a large number of sick staff.
    - v. Special Education Services: We will not be holding Special Education services in the building this week as we are trying to limit the number of individuals in the building.
    - vi. School Cleaning: The school has been getting a deep cleaning this week and part of last week. The custodial staff is aware of the sickness that has been going through our school and has been working hard on extra cleaning.
  - c. Staff Christmas Gift: Discussion was held with the board regarding staff gifts.
- IV. PATRON INPUT: Question regarding hours required by the state. A discussion was held regarding the virtual learning requirements.**

  - b. Trustee Liss motioned to approve the COVID -19 (Coronavirus) virtual learning until 12/9/2020. Vice-Chairman McClure seconded. 3 in favor. 0 opposed.
  - c. Vice-Chairman McClure motioned to approve Superintendent Jacobson and Clerk Heilesen to pursue the Staff Christmas Gifts. Trustee Liss seconded. 3 in favor. 0 opposed.
