- I. **Chairman Hulse called meeting to order at 7:00PM**
 - a. Chairman Hulse, Vice-Chairman McClure, Trustee Liss, Superintendent Jacobson and Clerk Heileson all present.
- II. **Chairman Hulse led the Pledge of Allegiance.**
- III. **CONSENT AGENDA - ACTION ITEMS:** Trustee Liss made a motioned to approve the consent agenda. Vice-Chairman McClure seconded. 3 in favor. 0 opposed.

- IV. **INFORMATION ITEMS/REPORTS**
 - a. Superintendent Report
 - i. COVID-19 Update: A few cases are in the valley with only a couple students being affected. EIPHD is no longer issuing mask mandates.
 - ii. Ski School Report: 7 days of ski school. Majority of the days were great weather and great student turn out.
 - iii. Kindergarten Volunteers: Mid-February Kindergarten started having parent volunteers in the classroom to help with reading and math.
 - iv. New Music Teacher: In January we had two applicants that had a full-day in-school interview with all the grades to get a feel for what the position would be like. Laura Huckin was hired in February for our music teacher. Music remains on Tuesdays and the students are really enjoying the new teacher.
 - v. Meet & Greet Follow Up: No Updates. A discussion was held with the board regarding staff concerns. The board discussed attending weekly staff PLC Meetings, having classroom volunteers, and thoughts on reading programs.
 - b. Re-Opening Plans for 2020-21 School Year revisions.
 - i. Plan revisions (if needed): Discussion was held with the board. Teachers are deciding on mask mandates in their classrooms. The board agrees that having the reopening plan at 100% with mask mandates per teacher is working well.
 - ii. EIPH moved Bonneville County to Moderate Risk: No mask mandate put into place for east Idaho. Masks are recommended if social distancing cannot be done.
 - iii. April School Schedule: 100% in school. No changes.
 - c. Swan Valley School District #92 2000 level policies: Small discussion held with the board.
 - d. Disposal of 2004 Ford Taurus (Sealed Bids) - Swan Valley School District Policy 9100: One bid was handed into the office. The sealed bid was received from Mr. D. Jacobson for \$511.00.

 - c. Trustee Liss motioned to approve the Disposal of 2004 Ford Taurus (Sealed Bids) to D. Jacobson. Vice-Chairman McClure seconded. 3 in favor. 0 opposed.
