 - a. Work session to prepare for 2020-21 school year budget: Discussion was held with the board of trustees regarding the budget for FY 2020-2021.

 - a. Superintendent Report: We received today, the DEQ Grant to upgrade and replace our water fountains and faucets.
 - i. COVID-19 (Coronavirus) The following is a list of potential discussion items as needed.
 1. Students will start returning iPads and School Supplies and cleaning out their personal items this week.
 2. 8th Grade graduation will be held Thursday, May 21, 2020 @ 7PM. This year it will have to be a family only graduation.

 - b. The Board of Trustees held a discussion regarding Policy 8120 - Bus Routes, Stops, and Non-Transportation Zones for 2020-2021 school year.
 - c. The Board of Trustees held a discussion regarding the current Policy 5400 - Leaves of Absence - Maternity Leave/Dependent Care/Immediate family care.
 - d. Discussion was held regarding Policy 3500, 3520, 2210, 2210P - Potential Issues to Address for School Closure and what the percentage rate of absent students should be and a guideline to follow.
 - e. Discussion was held with the board of trustees regarding 2020-21 School Lunch Prices.
 - i. Kids Lunch - \$2.50, raised 0.10 last year, guidance is to raise to \$2.62
 - ii. Adult Lunch - \$3.95, raised 0.10 last year, suggest raising 0.10
 - VI. **PATRON INPUT:** Patrons expressed concern for an aid in K-2 classroom for 2020-2021 school year. They feel that the class is large and could use extra hands and eyes to help with reading and math subjects.
 - VII. **ACTION ITEMS**
 - a. Vice-Chairman Scholes motioned to leave 2020-21 School Lunch Prices at the same rate as 19-20 school rate. Trustee Hulse seconded. 3 in favor. 0 opposed.

Board of Trustees returned to open meeting at 8:05PM.




