Opening Doors for Students _



"It doesn't look like a dark, empty alleyway anymore," ETHS Senior Rafael Salinas '19 raves about the school's new accessible, secure and welcoming entranceway to the athletic wing. As a team leader and varsity letter-winner in football, wrestling, and gymnastics, Rafael knows the entryway well. "It is more aesthetically pleasing with a vibrant look that conveys, this is where you're going to compete!" Now ETHS families and fans can pass through blue and orange décor and a stunning atrium to the Willie May Field House and Beardsley Gym to watch numerous Wildkit sports events. Accessibility to second floor gyms is now possible with an elevator.

Thanks in part to your support, ETHS underwent a comprehensive renovation last summer to enclose the previous open walkway and create a community gathering space. "It's a great improvement for all students and athletes," said Rafael. **"The safety staff at the entrance make the students feel safer. Before the covered entrance, I remember having to wait outside for a ride after practices - that wasn't fun in the middle of winter!"**

"There's a hominess to this part of the school that wasn't there before," Rafael beams. Students can hang-out on multi-tiered bench seating in the bright sky-lit common space. Handy charging ports make it easy for students to charge their Chromebooks and get homework done.

The entranceway is a new gateway to the school that inspires considerable Wildkit pride – another extraordinary enhancement thanks to you.

New Entranceway to the Athletic Wing

New Chem/Phys Labs & ETHS Research Center

ETHS's celebrated Chem/Phys program took on a new dynamic with a \$1.6M renovation last summer. The rebuilt and re-equipped labs, along with a newly created ETHS Research Center, were made entirely possible through the generosity of ETHS Foundation supporters, including significant support from Leonard D. Schaeffer '63, Chem-Phys alumni and a 50th reunion gift from the Class of 1967.

"The changes to the Chem/Phys classrooms are amazing," said Owen Travis '19, a senior headed to Princeton in the fall. Owen's passion for the sciences, kindled in middle school, has expanded with the rigorous inter-disciplined program and he speaks with deep appreciation for the enriched learning facility. "We have all the necessary resources to learn and I feel so lucky to be at a school where these resources are available." There are modular lab tables, generous amounts of cabinetry, pull-down electrical outlets from the ceiling and four chemical fume hoods with optimal viewing for demonstrations.

It's the ETHS Research Center that is the program's centerpiece, open to all students grades 9-12, who have scientific curiosity. The Research Center features space for physical experiments and huge walls of whiteboards for computational work that **"look right out of a college classroom – or a movie,"** said Owen. "There are even small improvements like a spout for distilled water available for experiments," he added with delight.

Physics teacher Dr. Mark Vondracek envisioned this as **"a facility for research and independent work where kids can get their hands dirty, prepare research for competitions and collaborate with people all around the world."** The exciting addition of teleconferencing technology allows students to connect their scientific inquiry to students around the world and strengthen their sense of global citizenship.

Because our students are the next generation of leaders and change-makers in our world, this advancement goes beyond science and gives them the tools they need to make a broader impact.





Foundation Funds New Engineering Lab and Makerspace

With an increased interest in engineering and technical education, the award-winning Project Lead the Way classes have grown in recent years. This year, donors of the ETHS Foundation provided \$65,000 to create a new engineering lab and makerspace to meet this need. In courses like Principle of Engineering and Civil Engineering and Architecture, students work in teams and use 3D software, exploring hands-on activities and projects to design solutions. An adjoining makerspace offers the students more opportunity with independent projects.






STEAM Course Gets Grant




