

## **ASSESSMENT UPDATES**

## April 1, 2020

Assessment and Accountability Waiver Approval: The U.S. Department of Education (USEd) has approved a request by the Delaware Department of Education (DDOE) to waive certain requirements in section 1111 of the Elementary and Secondary Education Act of 1965, as amended (ESEA) related to assessment and accountability requirements. According to USEd, DDOE's <u>waiver requests</u> appear to meet all statutory requirements and, accordingly, USEd intends to issue a formal approval of the DDOE waiver request in the coming weeks. DDOE has been granted permission by USEd to begin to implement the waivers while awaiting formal approval. | Assessment      | Students who missed make-up date will be eligible to test in the fall.  • Accommodated Tests:  o If students completed all 3 parts OR only Math and ERW, return tests to College Board. Students can receive a reportable total score without essay.  o If students did not finish Math and ERW, tests are sent to DOE for shredding. Students will be eligible to test in the fall.  • Schools that did not finish PSAT10 can finish during fall make-up date.  • Paper score reports for PSAT 8/9, PSAT 10 and PSAT 10 NMSQT are on hold until schools re-open. | School Day testing can retrieve their scores in the Student Portal.  Teachers cannot access scores until all assessments are returned and data validated.  Fall make-up, October 14, will be available for students who missed make-up date or did not finish testing during the accommodated window.  Additional Options:  Working with vendor on the option to offer vouchers for students interested in Saturday testing prior to fall make-up date.  Working with vendor on the option for students to have a second sitting for SAT if summer Saturday dates are cancelled. |
