

I have not served in a School Board role per se, however, I do currently serve on the Board of Directors of The Committee of 100, which is a non-profit organization advocating better policies and practices in economic development for the state. I also served on an ad hoc advisory board for Immaculate Conception School, Elkton MD, for two years in the early '90s. I was asked to join the ICS team, specifically to assist in implementation of financial & budget planning methods that might have allowed school administrators to recognize the school's approaching insolvency and redirect school management onto a long-term course for success. After overhaul of their planning approach, the school has continued in operation for two decades, and the Diocese of Wilmington asked my permission to adopt the budget analysis / planning tool I provided throughout their school system. While this is a narrowly focused aspect of school management, our STEM Academy proposal intends to use funding provided by taxpayers for school operations. As one of those taxpayers, I believe those funds

must be appropriately managed while the school administration also delivers on all other aspects of the school charter.

5. Why do you wish to serve on the board of the proposed charter school?

In recent years, I have personally experienced the difficulty of finding job candidates with acceptable English, math, and science skills among the pool of regional high school and college graduates. Far too many lack either decent skills in STEM-focused subjects, or an appreciation of what opportunities are available if they have those skills. This is a problem in Delaware, this region, and this country as a whole. Our society cannot sustain its present level of social development if there is a serious shortage of young people possessing the skills to operate and maintain our existing infrastructure, much less achieve further advancements in our standard of living. This issue threatens our competitiveness as a state, as a region, and as a country in the world economy.

6. What is your understanding of the appropriate role of a public charter school board member?

Fundamentally appropriate activities include providing guidance on overall direction of school development while ensuring that the school stays within the guidelines and regulations of the Delaware Dept. of Education, state & federal law, and the expectations of the community as embodied in the school charter. The Board should be:

- hiring appropriate school administrators and staff to execute the development plan, deliver the curriculum, manage public funds, and administer school activities on a day-to-day basis,
- monitoring performance of those personnel to ensure compliance with legal and charter requirements, and
- instituting corrective measures when necessary.
- 7. Describe any previous experience you have that is relevant to serving on the charter school's board (e.g., other board service). If you have not had previous experience of this nature, explain why you have the capability to be an effective board member.

Excluding the direct experience with the Immaculate Conception elementary school mentioned in question 4 and the ongoing advisory board capacity with Delaware Tech, I have not previously served in a position holding responsibilities specifically on the governing board of a school.

I do have experience in positions wherein:

 I helped develop governance for a national organization, helped develop an ANSI national standard, and assisted in development of and performed implementation of industry-wide operating rules & regulations for protection of public safety, health and property;

- I have been responsible for ongoing compliance with regulations for both daily operations and emergency response to protect life and property for nearly two decades;
- I have put three children through high school and college, two of whom are in licensed
 professional fields (architecture, investments & financial management), and one who is
 an aircraft systems development specialist for the US Navy;
- I have successfully navigated a compressed engineering curriculum as a student, such that I understand the preparation needed to successfully graduate from technical studies, and have worked in professional fields of technical employment for over four decades.

I also know that too few of our high school students today are a) prepared to succeed in an engineering or related science, technology or mathematics course of study, or b) aware of the opportunities that might await them in technical careers in general. While many of our young people demand and use the products and services these careers produce on a daily basis, a large proportion of this population segment have little or no understand of how these products or services are created and provided to them.

I also serve on the board of a non-profit, business oriented organization focused on improving economic growth in Delaware, and have been a volunteer instructor for elementary school children in courses to teach them how the economy works, and how technology and other products and services they will need are created and delivered.

I am willing to devote a portion of my remaining time on this Earth to helping improve the opportunities available to children in Delaware for a solid technical education.

8. Describe the specific knowledge and experience that you would bring to the board.

While I am not a professional educator, I am a professional with skills in

- engineering, particularly emphasizing energy transformation, delivery & usage
- financial analysis & investment management
- strategic planning & risk management
- · crisis management & business recovery planning, and plan implementation
- economics
- applied engineering research & technical development
- regulatory compliance
- development of operating departments, programs and projects
- · overcoming life's challenges to achieve goals
- providing guidance and encouraging inquiry through raising my own children, mentoring others, and teaching Junior Achievement courses to elementary students
- a low-key, collaborative approach to building successful teams that achieve objectives

School Mission and Program

1. What is your understanding of the school's mission and guiding beliefs?

Our organization's Bylaws, and Mission and Vision statements (paraphrased for brevity as follows) state that the purpose for which we organized included three objectives:

- A. provide an educational opportunity to any Delaware-resident student consistent with the Delaware Code and requirements of the Department of Education;
- B. provide opportunities for students to complete a rigorous science, technology, engineering and math (STEM) based curriculum that includes hands-on learning, integrated coursework, project based learning, and the potential for internships with Delaware industry; and
- C. produce ethical students with skills in self-reliance, logical thinking and the principles of science, and able to apply these skills using creative thinking to approach and solve problems that better our society.

I support the Bylaws and these objectives.

2. What is your understanding of the school's proposed educational program?

The proposed program is for an "open enrollment" school that targets the 9th-12th grade student interested in a potential career in fields of engineering, environmental sciences, or energy services, or closely related fields. Our expectation is to locate the school somewhere in New Castle County. Once created, the school will provide students within reasonable travel distance a challenging curriculum that prepares them either for advanced technical study in college or university, or for technical school paths to careers in services or industry.

We have focused extensively within our Board, technical advisory group, and external specialists on developing a hands-on approach of project-based learning combined as needed with more traditional instruction, with the coursework coordinated so that it supports and integrates learnings across different subject areas within the students' activities. Of course, the program must support achievement of state standards in all subjects, but it will be intended to allow students to exceed state educational standards and excel in the career fields being targeted.

3. What do you believe to be the characteristics of a successful school?

The students who graduate have to meet the needs of the marketplace, resulting in steady employment. Cranking out graduates who are chronically unemployed, or worse, unemployable is a waste of the taxpayers' past and future taxes. Generally, a thriving society will display economic growth through job creation that provides employment to our young people. Successful students will contribute their skills and knowledge to perpetuate the growth of the local (or regional / national) society they live in. High school provides a critical introduction to the needs of the real world. High school provides basic understanding of concepts behind the skills and subject knowledge that form the basis of either technician training or further education towards professional careers that support society's needs.

To be successful, the school must

- motivate the student to understand as much of their subjects as they can absorb,
- provide faculty resources that the student trusts and respects, thereby reinforcing the importance of the students efforts,
- provide learning resources that reflect the technology needs of the higher education institutions and/or industries that interest the student as the next step in their career path,
- equip the student with skills and knowledge that are relevant to their future needs in the
 job market and their chosen field, while also providing an understanding of ethics and
 societal context in decision-making situations.

As I have attended multiple colleges and universities, I saw schools that both successfully provided the above and those that failed to provide the above when examined in regards to the needs in specific career paths. I know that not all schools provide all needed courses and services to all their students. This may be because of inability to support certain subject areas, lack of funds, or lack of awareness of new or changing career field requirements. Our STEM school must provide resources appropriate for preparing a substantial majority of our students for a range of STEM-related careers, whether they stay through graduation or transfer to other schools to pursue a different direction. The right mix should prepare students for either advanced education or employment in STEM-related jobs, as both paths fit STEM career directions. Meeting this need is mandatory if the community is to view the STEM school as an attractive option. If the community sees their children successful in pursuing STEM-related careers, then parents will continue to send their children to this school to pursue STEM-related career choices.

4. How will you know that the school is succeeding (or not) in its mission?

Unfortunately, even if we have excellent faculty and administrators and all the resources the school needs to deliver instruction, it will still take years before we can be certain that the school is succeeding in delivering an education to our students which prepares them well for their career path.

Long-term indicators would be the success rate of students in entering STEM-based careers, thriving in those careers, and accomplishing work that betters the living standards of our society. That measurement path will take one or more decades to generate answers, but there will be many people who want to know if the school is a worthwhile investment of taxpayer money over a much shorter time scale.

Student retention rates, graduation rates, and attendance rates will likely be some of the measures examined. Student results on state testing relative to other schools will also be examined to see if the students do exceed the state averages for STEM subjects as would be expected from a student body of a STEM oriented school. The exact suite of performance measurement indicators is not fully established yet, but I have a high level of confidence that we will be looking at both quantitative and qualitative factors to determine success or failure, and can borrow from other school evaluation structures in developing the suite of indicators.

Governance

1. Describe the role that the board will play in the school's operation.

The Board has several duties in providing leadership, direction, and adjudication of the actions to be taken in operating the STEM Academy.

The Board defines policy and goals to support the vision, mission, and objectives of the school consistent with the requirements of the state issued Charter. The Board's policies must support transparency for the public and regulators regarding school administrative actions, operational practices, and financial health.

The Board will hire senior and support staff to administer all the functions of the school entity, and hire faculty to deliver instruction to students. The Board may also contract for any outside support services needed to develop, operate or maintain school facilities and provide needed services via established procurement procedures. Transparency is particularly important in this area.

The Board provides the checks & balances in the relationship between administrators, other staff, and oversight agencies, ensuring that budgets are being appropriately created, funds are appropriately raised, spent and tracked, laws and regulations are being followed, and activities of the school conform to the social, ethical, and legal expectations of the state, community, parents and students for protection of their interests. As part of this governance function, the Board holds the authority to resolve budget and personnel issues, or other issues of policy interpretation that may arise in the course of school operation.

There is one other role which hopefully is rarely if ever faced during school operations, but which I consider important to be addressed by the Board. This is advance planning for and situational management of any event which threatens student, personnel or community safety. In such a case, the Board has to intervene appropriately to protect the students, the community, and school facilities. The Board therefore should seek to include members who are familiar with emergency planning and crisis management, and preferably who are experienced in dealing with such situations. Development of good relationships with community leaders and agencies would be highly desirable in executing this role.

This is a very simplified description of what I am certain is a more complicated process. These are the most important functions of the Board in my mind at this time, but further involvement in this effort will likely expand my degree of understanding of the Board's roles and responsibilities.

2. Provide a forecast of where you see the school after its first year of operation and then again in four years.

This school may not be 100% functional and completely mature after its first year of operation no matter how hard everybody may work to achieve that state. This effort is not

"baking a cake" simple. Everyone involved in the day-to-day operation is going to be watching or watched to see if what is expected matches what is being delivered, and there are likely to be some adjustments in approach or direction. Adjustments may be required because some element of the plan doesn't materialize as expected, regulations change or are interpreted differently by various parties, or the student body doesn't grow as expected. Year One will produce changes, but if we do a good job of planning and provide flexibility and reasonable guidelines, this school should complete Year One with a limited list of improvements needed.

By Year Four, the STEM Academy should be graduating the initial class of students. The operation of the school should be fairly smooth at that point, and we should also be looking to see what adjustments in goals, practices and policies may be needed over the next five years, If the school has had a significant number of transfer students into the upper grades to provide indication of their success at moving on to higher education or specialized job instruction in a trade in the first three years, that may provide a picture of the school's success at meeting market needs for STEM skills. While four years is a bit early for determining the trend, it can certainly provide a baseline for measurement of the trends going forward.

3. What specific steps do you think the charter school board will need to take to ensure that the school is successful?

I expect the first four or five years will require greater involvement from Board members than in later years. This involvement is likely to be with both the administrators and faculty, and perhaps even attendance of some school events to interact with students and parents. The Board will have to ensure that a sense of community is built within the school, a sense of security and hope for students that they are on the right path if they work diligently, and a sense among parents of student that their children are receiving one of the best educational experiences that can provided with the resources available. The Board cannot, however, push aside the administration or faculty in the relationship with students and parents, as the Board's contact is not supposed to be day-to-day, nor can the Board serve as the source of answers to all questions. Given the approach intended for this school, one of the key activities the Board members can engage in is creating and expanding relationships with local industry (in the very general sense of the word) to build acceptance and support of the school and build a concept of team learning among students. This involves bringing in industry to explain what they do and provide students with knowledge and understanding of the role of technology and community employers within our society. We hope to achieve industry participation in the delivery of course lessons, particularly in defining learning projects for students and judging the success of those efforts.

4. How would you handle a situation in which you believe one or more members of the school's board were acting unethically or not in the best interests of the school?

I cannot think of a more serious problem than this one. It is potentially more serious than a budget crisis, possibly even worse than accusations that a teacher engaging in sexual

misconduct with a student. Unethical actions by Board members shake the trust of the community, threatening loss of its support, and provide a very poor example to the student body.

This situation would require bringing the rest of the Board together, and the smaller Board needs to notify the appropriate external authorities if a specific violation is suspected or determined to have occurred. I am not personally familiar at this time with the existence of any Department of Education regulations or procedures in such instances, but it would not surprise me if notifications must be made to the DOE as well as to law enforcement arms of the state government. In my view, any Board members implicated must be suspended or otherwise removed from any deliberations of the Board upon discovery of their potential involvement, and a determination of their fitness for continued service must be made once all the facts are gathered. If there are only allegations, the allegations must be investigated, possibly with the assistance of law enforcement agencies. While legal rights of the accused have to be respected, parents, students, and taxpayers deserve to be informed of what has or may have occurred and what is being done. This is particularly important if students are placed at risk by the alleged actions or tax revenues are involved in possible illegal actions. If the parties are accused of exerting influence over Board votes for personal gain through failure to disclose conflicts of interest, I would not take that very kindly, as it puts all members of the Board in an unacceptable place.

Each of our students will be working on their resume so they begin to get a sense of how they look on paper, and to reflect on the options for their careers. We will be developing relationships with local businesses. Some businesses will take students in for a tour and overview of what they do and what kind of workers they are looking for. Other businesses may come in and give a guest lecture or workshop. We will also send students to colleges for a tour to get them thinking and planning their future.

- In four years, the STEM Academy has a good reputation and our graduates are in the workplace and at colleges. We have a homecoming day each year to invite them back to tell us how they are doing. We also have a placement counselor and a web site that connects our students and alumni with employers and colleges. Our students have won science fair and writing competitions, our showcase is starting to fill with trophies and we've received favorable articles in the newspaper. Our teachers are working closely together and have developed a good school community that is supportive and encouraging of the students and that challenges the students to push them past their limits to develop more confidence. Several of our STEM Academy graduates come back to the school to address the younger kids and tell them how they have applied their STEM School learning in their college classes or their new jobs.
- In four years, the Board of Directors is at work on launching a K-8 elementary school! (I may be the only person on the Board that wants to do this! We'll see where we are in 4 years).

3. What specific steps do you think the charter school board will need to take to ensure that the school is successful?

- Fundraising to meet or exceed budget requirements
- Submitting the necessary Applications for Charters and Licenses
- Securing a building to house the school
- Direct building retrofit and furnishing
- Hiring the right Principal and teaching staff
- Teaching our students to be confident and professional
- Coaching our students as they complete applications for jobs and colleges
- Meeting with businesses and colleges and encouraging them to hire/accept our students
- Developing a Board Succession Plan

4. How would you handle a situation in which you believe one or more members of the school's board were acting unethically or not in the best interests of the school?

- Document exactly what transpired and the dates on which it happened.
- Write out what I think is happening and what I think needs to be done to cure the situation. This is to clarify my own thoughts.
- Talk with the President of the Board or another trusted Board member (or our Board's attorney, as long as there is no fee, or I'm planning to personally pay the fee) as a sounding board to see if I am the only one thinking this or if I'm missing something.
- Meet with the person in question, respectfully point out what I think is the problem, and ask them to tell me more about what they are thinking. Tell the person that I believe that the Board needs to discuss this matter as a group and that I'm planning to place it on the meeting agenda.
- At the meeting, discuss the issue respectfully and explain why I think the good name and reputation of the school is in jeopardy. Ask for the change/cure I think is appropriate (possibly in the form of a motion). Carefully listen to the Board member responses and comments. Modify my request if it makes sense to do so.
- I don't know enough about school boards to know what next steps are, like going to Department of Education or what. I can't imagine that would be necessary because I know and have worked with the board members and I trust them. I would like to learn more about what types of trouble boards get into.
- (P.S. This is a tough question! Hopefully, there is a procedure already written that we can follow. If not, we should write out a procedure now on how to handle that if it comes up in the future).
