Special Education Compliance Monitoring 2014-2015

Indicator 13 Transition Planning

The Department of Education ("DOE") is responsible for monitoring local education agencies ("LEAs") for special education compliance under IDEA, including transition services for students with disabilities (indicator 13). DOE must report annually to the Office of Special Education Programs (OSEP) the percent of youth with IEPs aged 16 and above with an IEP that includes appropriate measurable postsecondary goals that are annually updated and based upon an age appropriate transition assessment, transition services, including courses of study, that will reasonably enable the student to meet those postsecondary goals, and annual IEP goals related to the student's transition service needs. There also must be evidence that the student was invited to the IEP Team meeting where transition services are to be discussed and evidence that, if appropriate, a representative of any participating agency was invited to the IEP Team meeting with the prior consent of the parent or student who has reached the age of majority. Regulation: 20 U.S.C. 1416(a)(3)(B) the Individuals With Disabilities Education Act ("IDEA") and corresponding state regulations.

Since Delaware Regulations state transition services must begin with the earlier of the first IEP to be in effect when the child turns fourteen (14) or enters the eighth (8th) grade, or younger if determined appropriate by the IEP team, the DOE reviews all transition aged IEPs for Indicator 13 reporting.

DOE's Monitoring Activities

As Delaware engages in results-driven accountability there is a need to provide a comprehensive status of where Delaware stands in providing transition planning and services for students with disabilities. Thus, DOE began implementing a new monitoring process for Indicator 13 this year. Beginning with the 2014-2015 school year all districts and charters having transition age (age 14 or in the 8th grade) students will be monitored for Indicator 13 each year. The following process is now being implemented in a two-phase process:

Phase 1 – LEA Self-Assessment

LEAs will be required to conduct a self-assessment of <u>all</u> IEPs for students age 14 or in
the 8th grade and above for transition planning and services in the fall.
(In the fall of 2014, DOE provided LEAs with an electronic spreadsheet to capture all
data. LEA self-assessment data was submitted to DOE on March 1, 2015).

Phase 2 – DOE Validation of LEA Submitted Data

 DOE will review a representative sample of the submitted data for validation. All secondary schools will be included in the verification process.

DOE will complete the validation process. If any individual non-compliance in transition planning and services is found, the LEA will move into the Prong1/Prong 2 monitoring process according to the OSEP 09-02 memo in which the Federal DOE outlines requirements for states to conduct two phases of monitoring activities.

A. Prong 1 - Student Level Corrective Action

As mentioned, all noncompliance must be corrected at the individual student level, and is described in Section 3 of the Monitoring Report. The LEA is responsible for submitting Section 3 of the Monitoring Report documenting completion of all individual student corrections to the DOE no later than <u>September 30, 2015</u> The DOE will review the individual student records to verify completion of required corrections.

Note that the correction of IEPs is not required if: (a) the student is no longer enrolled in the LEA; (b) the student was dismissed from receiving special education services; or (c) the student no longer attends school due to graduation or other reasons. The Monitoring Report contains a section for your LEA to report when these circumstances occur.

Additional corrective actions may also be required, such as staff training, depending on the root cause of the non-compliance.

B. LEA Level Corrective Action

The DOE will be reviewing records for the regulatory transition item that is less than 100% compliant. The percentage levels for your LEA are found in Section 4 of the Monitoring Report. Before starting any corrective actions, the LEA must conduct a Root Cause Analysis to identify the specific reasons the problem exists within the LEA. Depending on the reasons identified, the LEA should then tailor specific action steps to remedy the problem. Corrective actions can include, but are not limited to, self-audits and LEA review of student records, review of compliance data by teacher/school, specific trainings for targeted staff, and review of policies and practices at the LEA and school levels. Your staff should discuss plans and technical assistance options with the DOE team assigned to your LEA. The LEA's signed Corrective Action Plan will be due to DOE on or before August 28, 2015

Note, the DOE is requiring each LEA to provide training to staff in the transition areas in which compliance is below 100%. The training should be specifically developed by each LEA to ensure staff will be properly implementing the regulations. "Training" can include: (a) presentations to staff by an expert or consultant in special education regulations; (2) distribution of written materials to staff; and/or (3) use of technical assistance documents and professional development modules sanctioned and approved by the U.S. Department of Education.

The DOE team will monitor the Corrective Action Plan developed by the LEA and review a timeline for submitting updates to the DOE. We are asking LEAs to report to the DOE on the completion of their corrective actions no later than <u>October 30, 2015</u>.

C. Prong 2 - State Verification Action

DOE will conduct a Prong 2 verification as part of the next cycle of compliance monitoring which will occur in the fall of 2015.

D. Indicator 13 Findings

As a result of the review of you LEA's data, the Department has determined your LEA is 75% compliant with federal Indicator 13 requirements. Areas of identified noncompliance are listed on the attached document by student name.

Summary

<u>Background</u>: During the 2014-2015 school year, LEAs conducted self-assessments on transition by reviewing student records and IEPs for compliance with special education transition regulations. Department of Education ("DOE") representatives then validated the self-assessment data submitted from LEAs by reviewing a random sample of student records and IEPs provided to LEAs. DOE provided a compliance monitoring report to the LEA summarizing the findings. This corrective action plan describes the strategies and steps that the LEA will take to ensure compliance with special education transition regulations, including professional development and a system of internal controls.

<u>Due Dates</u>: This plan must be submitted by **August 28, 2015**. Additionally, the LEA must complete individual student corrective action and by **September 30, 2015** and professional development for staff in the areas identified in the monitoring report by **October 30, 2015**.
