WHEREAS, the Department of Education, acting pursuant to a pending Bond and Capital Improvement Act has considered the necessity for a school construction program to include, but not be limited to, the planning, constructing, equipping, and additions to the Clayton Intermediate School, and the planning, constructing, equipping, and additions and renovations to the North Smyrna Elementary School, in doing so, has taken into consideration the condition and quality of existing school facilities within the school district, and all other matters and conditions pertinent to the determination of the present necessity of such a school construction program, including the reasonable future development or diminution of the school district, NOW THEREFORE,

BE IT RESOLVED by the Department of Education as follows:

(1) The Department of Education has ascertained and determined that there is present necessity for the following school construction program in said school district:



(1) The Department of Education has ascertained and determined that there is present necessity for the following school construction program in said school district:




