Plessy v. Ferguson

Plessy v. Ferguson was an 1896 Supreme Court decision allowing separate facilities on the basis of race, a doctrine which became known as "separate but equal." The case originated when Homer Plessy, an African American, boarded a railroad car reserved for white passengers, thus violating a Louisiana statute. The Court upheld the state law.
