

2018-19 Adjustments for DPAS II Career & Technical Education (CTE) Measures B and C

Over the past several years, Delaware’s Career & Technical Education (CTE) Programs of Study have undergone extensive revisions to ensure alignment between academic and technical instruction. These content shifts have caused many DPAS II Measure B assessments and Measure C Growth Goals to be out of alignment with current Programs of Study.

The Delaware DOE conducted a review of current Measure B assessments and determined the Measure B assessments named in the chart below are out of alignment. These assessments have been removed from the approved Measure B assessment list beginning in the 2018-19 school year. Any teacher for which a Measure B assessment is no longer available will be designated a Group 3 educator. Group 3 educators will use two Measure C Growth Goals for their Student Improvement Component measures.
