What is Title I?

Dallas Elementary is identified as a Title I school as part of Every Student Succeeds Act (ESSA). Title I is designed to support State and local school reform efforts tied to challenging State academic standards to reinforce and enhance efforts to improve teaching and learning for students. Title I programs must be based on effective means of improving student achievement and include strategies to support parental involvement. <u>What is it?</u> This is a plan that describes how Dallas Elementary will provide opportunities to improve parent engagement to support student learning. Dallas Elementary values the contributions and involvement of parents to establish an equal partnership for the common goal of improving student achievement. This plan describes the different ways that Dallas Elementary will support parent engagement and how parents can help plan and participate in activities and events to promote student learning at school and at home.

How is it revised? Our Parent and Family Engagement Plan is updated every year. In early spring, a survey is made available to all parents, and may be taken on-line or on a paper copy that is sent home to all parents of our students. It is advertised through bulletins, phone calls, and during parent meetings. The survey asks for feedback on components of the current Parent and Family Engagement Plan and parent involvement opportunities that took place during the school year, and invites suggestions and input in the development of the updated Parent and Family Engagement Plan. Participation from all parents is also sought through responses on feedback forms provided at all parent involvement meetings and activities, the availability of a suggestion box, and meetings planned specifically for developing the policy together.

Once the policy is created, it is presented to parents and school staff (in parent involvement meetings, through the school website, and accessibility to paper copies in the school) for final agreement; it is then introduced as the Parent and Family Engagement Plan for the current school year at the Annual Title I Parent Involvement Meeting which takes place in early fall.

<u>Who is it for?</u> All students participating in the Title I, Part A program, and their families, are encouraged and invited to fully participate in the opportunities described in this policy. Dallas Elementary also provides full opportunity for participation of parents and guardians with limited English proficiency (by providing as practical, language translation services), parents/guardians with disabilities and parents/guardians of migratory children.

Where is it available? Dallas Elementary School's Parent and Family Engagement Plan is distributed to all parents/guardians of students in our school via Class Dojo and Blackboard. We strive to make continual progress in working with our parents and always welcome any feedback and suggestions throughout the school year.

3rd Grade -3rd grade students will demonstrate growth in reading by performing in the next Acadience (Maze) proficiency level. *Thirty (36%)* students demonstrating skills in the Well Below range will demonstrate improved reading skills to a minimum of the Below range. *Fifteen (18%)* students demonstrating skills in the Below range will demonstrate improved reading skills to a minimum of the At Benchmark range. *Nineteen (23%)* students demonstrating skills in the At Benchmark range will demonstrate improved reading skills to a minimum of the Above Benchmark range. *Twenty (24%)* students demonstrating skills in the Above Benchmark range will remain in this proficiency level by increasing their composite score.

4th Grade - 4th grade students will demonstrate growth in reading by performing in the next Acadience (Maze) proficiency level. Forty-one (49%) students demonstrating skills in the Well Below range will demonstrate improved reading skills to a minimum of the Below range. Nineteen (23%) students demonstrating skills in the Below range will demonstrate improved reading skills to a minimum of the At Benchmark range. Ten (12%) students demonstrating skills in the At Benchmark range will demonstrate improved reading skills to a minimum of the Above Benchmark range. Fourteen (17%) students demonstrating skills in the Above Benchmark range will remain in this proficiency level by increasing their composite score.

5th Grade - 5th grade students will demonstrate growth in reading by performing in the next Acadience (Maze) proficiency level. *Thirty-five (49%)* students demonstrating skills in the Well Below range will demonstrate improved reading skills to a minimum of the Below range. Fifteen (21%) students demonstrating skills in the Below range will demonstrate improved reading skills to a minimum of the At Benchmark range. *Six (8%)* students demonstrating skills in the At Benchmark range will demonstrate improved reading skills to a minimum of the Above Benchmark range. *Sixteen (22%)* students demonstrating skills in the Above Benchmark range will remain in this proficiency level by increasing their composite score.

SMART Goal 3: Increase the number of students earning a Math achievement level score of 3 or higher on Georgia Milestones as outlined below: • Increase the number 4th grade earning a Math achievement level score of 3 or higher from 20% (20 out 102 students) on the Spring 2022 GA Milestones to 28% (24 of 84 students) on the Spring 2023 GA Milestones. • Increase the number 5th grade earning a Math achievement level score of 3 or higher from 32% (22 out 68 students) on the Spring 2022 GA Milestones to 38% (27 students out 70) on the Spring 2023 GA Milestones.

2nd Grade will decrease the number of students needing number core and BFF DTM interventions from 67% (48 students) to 30% (22 students).

3rd Grade will decrease the number of students needing number core and or add/subtraction A DTM interventions from 65% (50 students) to 30% (23students)

4th Grade will decrease the number of students needing add/subtraction DTM interventions from 77% (57 students) to 40% (30 students)

5th Grade will decrease the number of students needing multiplication/division DTM interventions from 84% (52 students) to 40% (25 students)

When Do Children Learn?

Eighteen years is 157,680 hours—that's a lot of hours! From the time a child is born until he or she graduates from high school, what percentage of the child's waking, learning hours are spent at home and at school? **Let's do the math!**

Assume kids sleep about 8 hours each day; 24 hours per day - 8 hours sleeping = 16 waking hours per day

- 365 days per year x 18 years = 6,570 days
- 6,570 days x 16 waking hours per day =105,120 waking hours by age 18
- Assume kids are in school an average of 6.5 hours each day
- 180 school days per year x 6.5 hours per school day = 1,170 hours of school each year
- 1,170 hours of school each year x 13 years (1 year in kindergarten + 12 years through high school) = 15,210 school hours
- 15,210 school hours ÷ 105,120 waking hours = .1446 or *only 14.46%* of waking hours by age 18 spent in school.

That means 85.54% of children's time is spent elsewhere—mainly at home. No wonder parent involvement has such a huge impact on children's school success!
