I'm the 4 Lead Education Associate with the Charter School Office, and I have been appointed by 5 the Secretary of Education to conduct this 6 7 public hearing. The Academy of Dover Charter School 8 has filed an application to modify its 9 10 charter to include a sixth grade. 11 As is required by law, the matter 12 was referred to the Charter School Accountability Committee for investigation 13 14 and report. 15 This joint public hearing is being 16 held by the Department of Education and the State Board of Education. 17 Now I will ask the other at the 18 19 table to introduce themselves. 20 MS. If you desire to speak 10 and have not signed up, please do so now. 11 Those that have not signed up will 12 not be permitted to speak and instead be asked to submit written comment. 13 14 All public speakers are limited to 15 three minutes. I reserve the right to impose 16 reasonable time, place, and manner restrictions if the speakers prevent this 17 18 hearing from accomplishing its goals in a reasonable manner. 19 This hearing's purpose is strictly 20 21 to collect public comment. Questions of the Department of Education, the State Board of 22 23 Education, or the charter school are not 24 permitted and will not be acknowledged.
