Criteria for Exam Exemptions

Course Grade Average = 80% or above

No exam exemption will be allowed if:

- The student's class average is not, at least, 80% **at the exam exemption deadline and at the time of the exam.**
- The student has 5 or more unexcused absences or 5 or more unexcused tardies to the classes they wish to exempt.
- The student has failed to turn in the Exam Exemption form by the **Friday, May 13, 2022, deadline. There are NO exceptions. Exam exemptions are a privilege and as such students must take full responsibility for getting the signed exemption forms turned in by the due date.**

Student Responsibility:

- Secure the Exam Exemption form as required & acquire all the necessary signatures.
- Return completed Exam Exemption form with parent signature to the **Front Office NO LATER THAN FRIDAY, MAY 13, 2022.**

Exemption Expectations/ Privileges:

- Students may only exempt **ONE Core** Course (Math, Science, Social Studies, English) and **ONE Elective** Course.
 - Exception: If the student has ALL core classes (4 total), then they can exempt 2 of those 4.
 - A student taking an AP Class and who is registered to take the AP Exam may exempt that AP final as an additional exemption
 - A student completing a CTAE Pathway and passing the EOPA for that class may exempt that CTAE final as an additional exemption.
- Student must be present and on time for non-exempt examination classes.
- Student must attend the exempt class during the exam period **if he/she is on campus.**
- Student must check-in and check-out appropriately if they do not plan to attend the class in which they have exempted the exam.
