Subject: Freire Charter School Planned for Wilmington, DE.

I want to express my strong objection to the site chosen for Freire Charter at 201 West 14<sup>th</sup> Street for these reasons... the location; the surrounding area and the building are unfit and unsafe for the intended purpose of a large population high school.

I have lived in the Midtown Brandywine neighborhood for 19 years and love the diversity, comradery, friendship and energy where we live. Ours is a model for Center City living. However, the logistics are very tight with a very few single houses, many double houses, row homes and apartments. All the connecting streets are one way and all have street parking, the vast majority, on both sides of the street.

The location chosen by Freire Charter is at the corner of Orange St (one way) and 14<sup>th</sup> St. (one way), a 90° very tight turn. This location will present safety issues for students waking to and from bus stops or drop off locations at Rodney Sq., Market St. and Washington St. And this is in good weather. Bad weather...heavy rain, snow and sleet will increase the safety risk exponentially. The sidewalks and streets will not be able to absorb the dramatic intensive increase in foot and auto traffic created by up to 500+ students coming in and out every day. 5 days a week and for after hour and weekend school functions. I understand the building will not any gymnasium "like" athletic space nor is there athletic space or a field outside...and these are high school students with unlimited energy!

How this proposed location for Freire Charter got this far is mind boggling. I defy you or anyone on your committee or staff to visit Orange and 14<sup>th</sup> and not come away shaking your head and asking "what were they thinking". I understand Freire first chose another location but could not secure it...so they at least "got it right the first time" but then failed with "Plan B".

Is my opposition to Freire based on opposing Charter Schools? Absolutely not! I think the Charter concept when planned, executed and managed correctly, can add to the educational options and opportunities for Delaware's kids in a very positive way. Two of my grandsons will enter 9<sup>th</sup> grade at Wilmington Charter this fall. They and their parents and are very excited. I am too.

I've worked for large multi-national corporations to small entrepreneur companies for 49 years and one principal has always applied..."if you start with a bad plan, you can expect the same bad results". Freire Charter located at 201 West 14<sup>th</sup> St. is a bad plan...a location completely unfit and unsafe for the intended purpose of a high traffic high school.

For these reasons and the many reasons expressed by others, Freire Charter should not be approved. But rather Freire should be directed to go back and fix the many serious issues that have been raised, including a new location and come back next year or later with a solid workable plan that will result in a quality school for addition to the Wilmington high school education platform.
