Dear Secretary Murphy,

Over the last two weeks I have met with several new members of the Pencader Business & Finance Charter High School Board of Directors, at their request, to discuss proper board training and to brainstorm management ideas if the school is allowed to move forward under review. I was not familiar with the current issues facing Pencader and could only draw from my experience in the development of a charter school as defined by Delaware law and DOE regulations. After performing an objective evaluation, I have two pressing concerns regarding Pencader's path forward with its charter: the need for a strong and well-trained Board of Directors and, more importantly, for the implementation of a strong, certified, experienced administrator to lead the school on a steady course (I am retired Navy). It is possible that the accountability committee has other concerns.

I was contacted by Frank McIntosh, Chief Operating Officer and Managing Director of the Jefferson Council, advising me of his appointment as Board Chair for Pencader, and requesting a conference. At our meeting I was informed that Pencader HS had hired a new head of school and the Pencader Board is actively pursuing Charter Board development training.

The Pencader Board's selection of Mr. Frank Hagen (side note: I really enjoyed working with and receiving guidance from Frank when he was at CSW!) as the principal is significant. He has been my mentor for many years and is one of the most respected educators in Delaware. Under his leadership, Newark HS was the flagship school of our state. I know you are new to Delaware so I want to offer an insider opinion. If Pencader is allowed to remain in operation, there is someone at the helm I believe will make it thrive. However, if the decision is to revoke the Charter, Frank Hagen is the man to provide the leadership for a smooth transition. The combination and strength of Mr. McIntosh as Chair and Mr. Hagen as Head of School is powerful and positive.

Training of the Board is critical as well and Mr. McIntosh has a solid plan in place for charter board development.

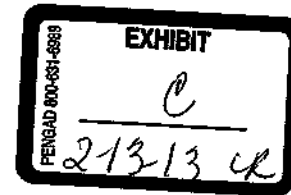
I believe in our Department of Education and trust any decision, either favorable or unfavorable as to the Pencader HS charter status, will be in the best interests of educating the children of the First State.
