

**Clayton County Public School Summer T.I.M.E. Learning**  
**Frequently Asked Questions**

**Q: My child did not pass the GMAS, are they required to attend Summer TIME Learning?**

A: Based upon Clayton County Public Schools Board of Education decision to “set aside” the state promotion and retention requirements for grades 3, 5, and 8, the Georgia Milestones End of Grade Assessment **will not be** used for promotion or retention decisions for 2017-2018. Therefore, summer school is not required.

**Q: Can I sign my child up for more than one camp?**

A: In Infinite Campus, students may sign up for a 1<sup>st</sup> choice and a 2<sup>nd</sup> choice. If selected, student may only participate in one program.

**Q: How will I know which camp my child will attend if accepted?**

A: Based on what is selected as a 1<sup>st</sup> and 2<sup>nd</sup> choice and if accepted, your child will attend the camp that is the closest to his/her home address.

**Q: My child has special permission to attend his/her school. Is transportation available for summer learning?**

A: School choice and special permission transportation request are not available during the summer months. Transportation requests are for students who reside in Clayton County.

**Q: Will students participate in field trips away from school?**

A: Camp participants will attend field trips away from school. Information regarding field trips will go home with student within the first 2 days of each camp.

**Q: What is the child to instructor ratio?**

A: The child to instructor ratio varies depending on enrollment and age of the students.

**Q: What are the ages ranges for the camps?**

A: Age ranges for each camp are located on the CCPS website.

**Q: Are different aged children in the same camp?**

A: Yes and no. Some locations do have multiple grade levels, but for the most part, students will only interact with students within their grade band (ie. Grades K-3, Grades 3-5, Grades 6-8, and Grades 9-12).

**Q: Who are the Summer Learning instructors?**

A: Summer Learning instructors include CCPS teachers along with District STEM Partners. All District STEM partners have undergone background checks with the school district. Summer Learning staff also includes site administrators and healthcare technicians.

**Q: Do you offer extended care?**

A: CCPS Summer Learning does not offer extended care services such as Campus Kids.

**Q: How do I apply for a camp?**

A: It is required that each student completes an online application. Applications are accessible through Infinite Campus Parent Portal.

**Q: What should my child wear to camp?**

A: The regular Clayton County Public School dress code will apply to summer learning programs. No tank tops, hats, sunglasses, T-shirts with suggestive or inappropriate slogans or short shorts.

**Q: How many days are the camps?**

A: Each camp consists of 4 days of learning (Monday-Thursday).

**Q: What are the camp start and end times?**

A: Instruction begins at 9:00AM and ends at 2:00PM.

**Q: Will I need to provide snacks and/or lunch for my child?**

A: Breakfast and lunch will provided for each camp participant.
